WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

SHELBY COUNTY

That in consideration of TEN DOLLARS (\$10.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt whereof is acknowledged, we, J. Devon Redding and wife, Karen L. Redding as Trustees under that INDENTURE AND TRUST for the use and benefit of J. Devon Redding, Ronald W. Ross, and Allen Foster dated April 7, 1974 and recorded in Real 288, page 259 in the Probate Office of Shelby County, Alabama, hereinafter referred to as J. Devon Redding and wife, Karen L. Redding, Trustees; and J. Devon Redding, Ronald W. Ross and Allen Foster as beneficiaries under said INDENTURE AND TRUST; and J. Devon Redding and wife, Karen L. Redding, Ronald W. Ross, unmarried, and Allen Foster, unmarried, individually, (hereinafter referred to as grantors), grant, bargain, sell and convey unto Allen Foster, (hereinafter referred to as grantee), the following described real estate, situated in SHELBY COUNTY, ALABAMA, to-wit:
