hereof, releases and forever discharges Grantor, its successors and assigns, from any and all liability, claims and causes of action whether arising at law (by contract or in tort) or in equity in connection with Grantor's past use or the condition of the premises and the past, present or future use and/or the condition of adjacent and nearby lands owned or controlled by it with respect to industrial, mining, mine waste disposal and quarrying operations, and whether such industrial, mining, mine waste disposal and quarrying operations be conducted by Grantor, or by Grantor's successors, assigns, grantees, licensees, contractors, permittees and lessees.

TO HAVE AND TO HOLD the above granted property to said Grantee, its successors and assigns, forever.

AND the Grantor, for itself, its successors and assigns, does hereby covenant with the said Grantee, its successors and assigns, that the property described above is free and clear from all encumbrances whatsoever, created by, from, through or under the Grantor except as stated above, and that said Grantor will forever WARRANT AND DEFEND the same with the appurtenances thereunto belonging, unto the said Grantee, its successors and assigns, against all lawful claims of all persons, claiming by, from, through or under the Grantor herein, except as stated above.
