KNOW ALL MEN BY THESE PRESENTS:

WHEREAS Norowal Construction Company, Inc.  
did on the 19th day of November, 1973, execute a mortgage to City National  
Bank of Birmingham, which mortgage is recorded in Mortgage Book 335

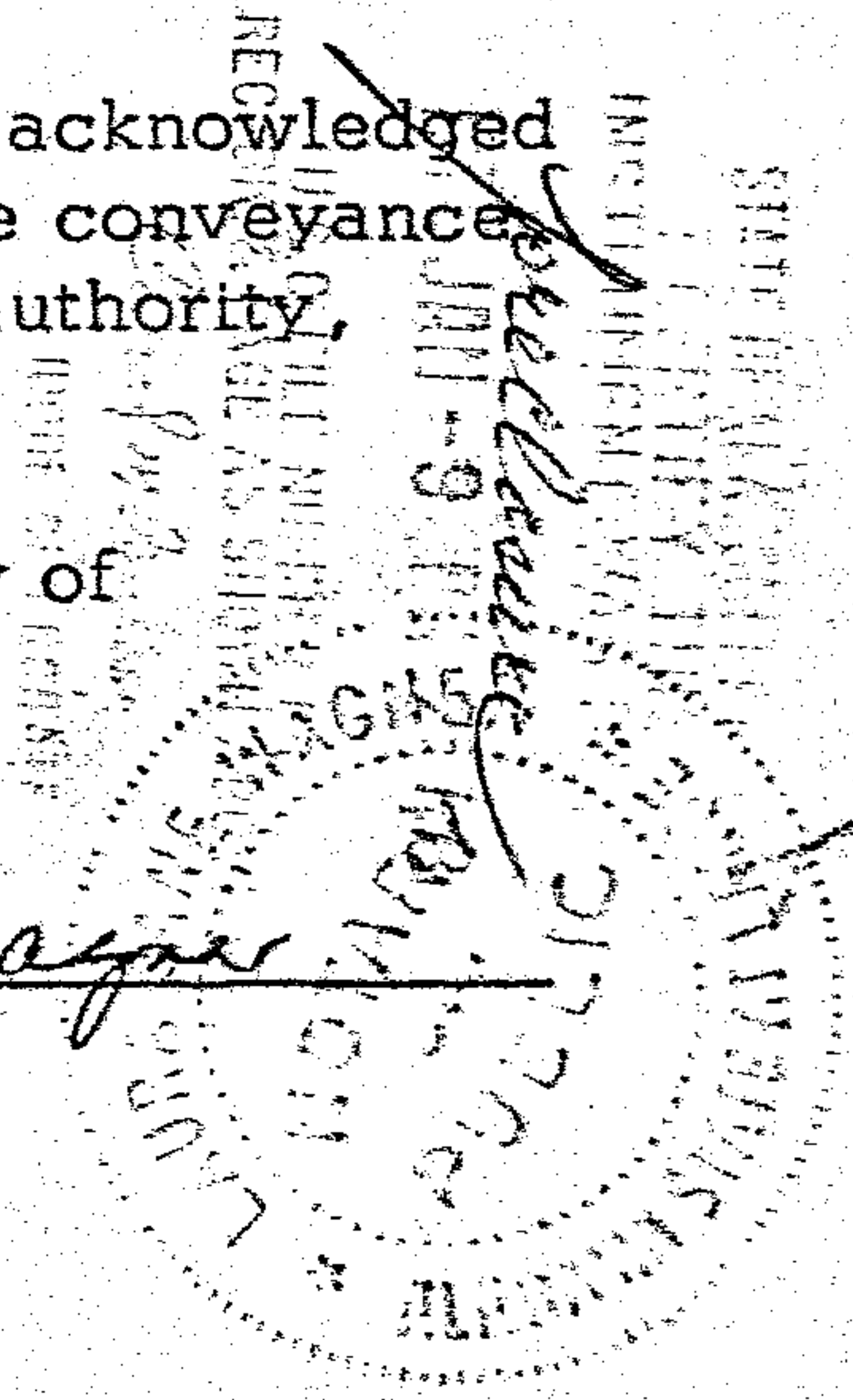
