Know All Men by These Presents, That in consideration of the conveyance by the State of Alabama, Department of Conservation and Natural Resources, Division of Parks, Monuments and Historical Sites to the undersigned grantor, Leon Aland, of certain real estate situated in Shelby County, Alabama, more specifically described as E 1/2 of SE 1/4 and SW 1/4 of the SE 1/4 of Section 9, Township 20 South, Range 2 West, the receipt whereof is hereby acknowledged, we, the said Leon Aland and wife, Leanore Aland, do grant, bargain, sell and convey unto the said the State of Alabama, Department of Conservation and Natural Resources, Division of Parks, Monuments and Historical Sites the following described real estate, situated in Shelby County, Alabama, to-wit:

N 1/2 of NW 1/4 and SW 1/4
of NW 1/4 of Section 19, Township
19 South, Range 1 West.

To have and to hold, to the said the State of Alabama, Department of Conservation and Natural Resources, Division of Parks, Monuments and Historical Sites and its assigns forever.

And I do, for myself and for my heirs, executors and administrators, covenant with the said the State of Alabama, Department of Conservation and Natural Resources, Division of Parks, Monuments and Historical Sites and its assigns,



that I am lawfully seized in fee simple of said real estate; that it is free from all encumbrances; that I have a good right to sell and convey the same as aforesaid; that I will, and my heirs, executors and administrators shall, warrant and defend the same to the said the State of Alabama, Department of Conservation and Natural Resources, Division of Parks, Monuments and Historical Sites and its assigns forever, against the lawful claims of all persons, except as herein set forth;

PROVIDED ALWAYS, however, that this deed is made upon the express condition that the State of Alabama shall use said real estate exclusively for public park, recreational, and conservation purposes; and,

PROVIDED FURTHER, however, that the title and right to possession of said real estate, together with any and all improvements thereon, shall revert to the United States of America upon a finding by the Secretary of the Interior, after notice to the State of Alabama and after an opportunity for a hearing that the State has not complied with the aforesaid express condition during a period of more than three years, which finding shall be final and conclusive.
