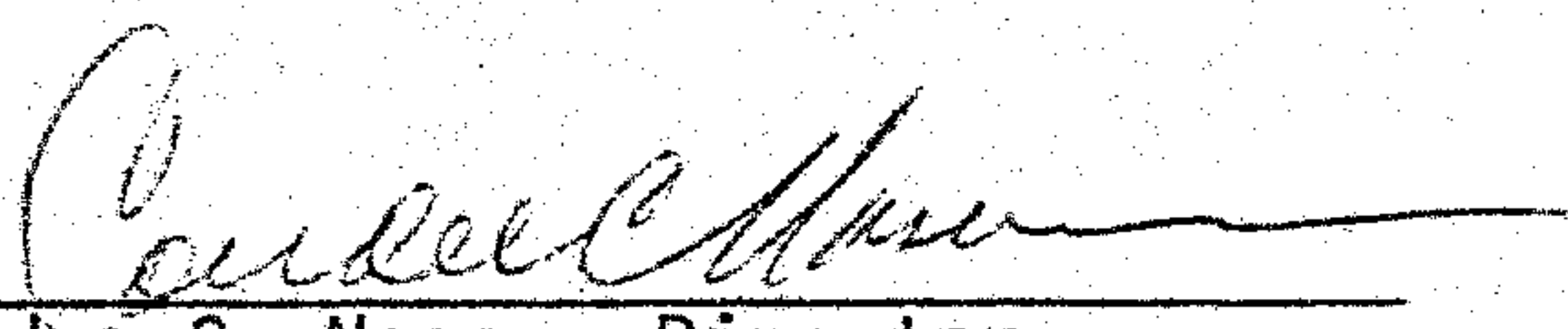

TO HAVE AND TO HOLD to the said Leon Aland his heirs and assigns forever.

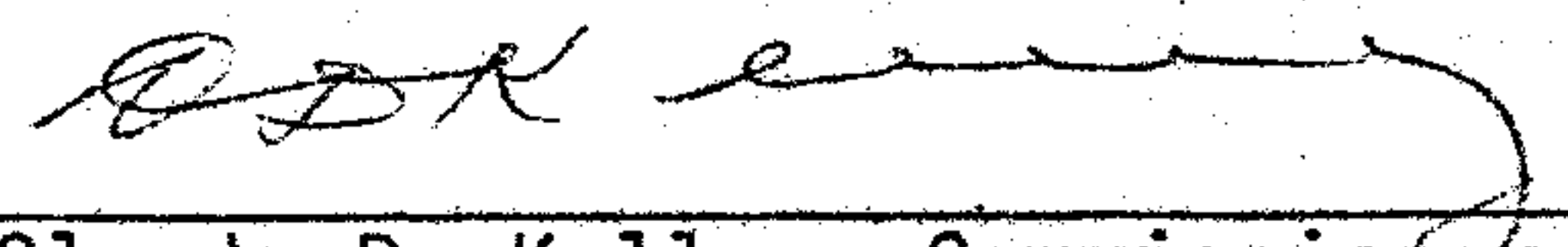

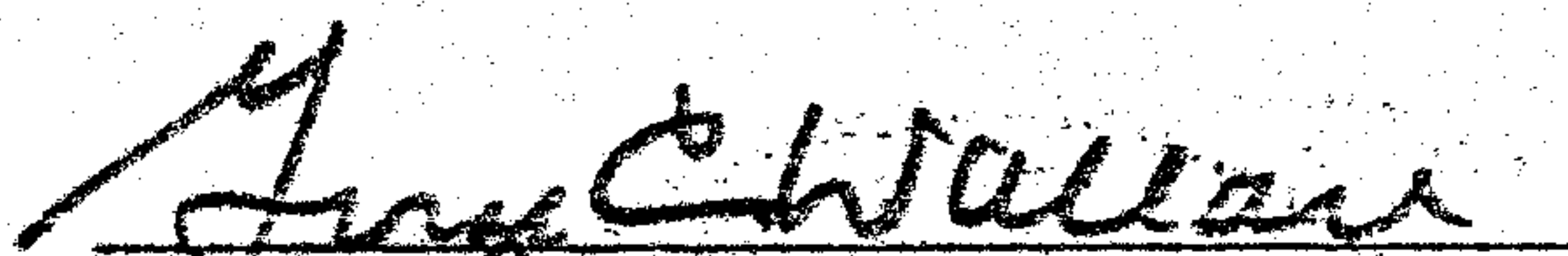

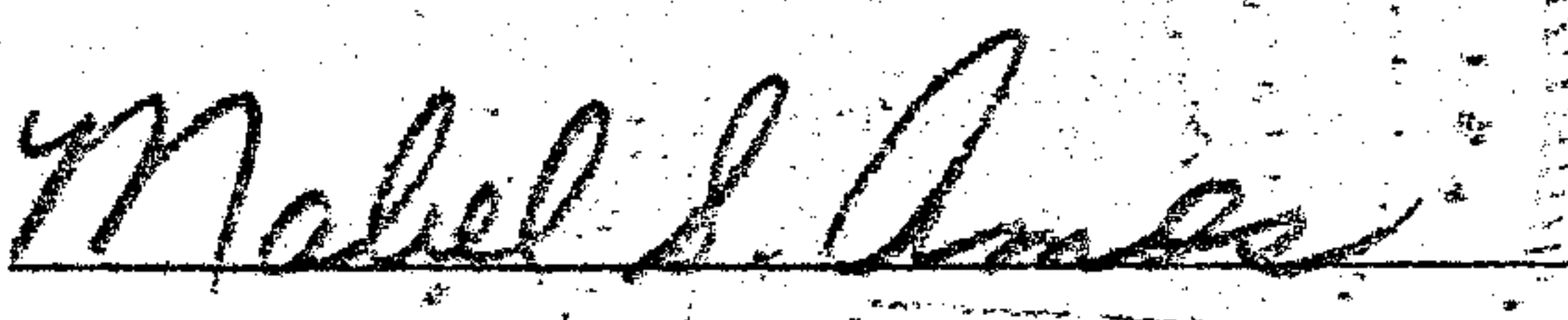
