WHEREAS, the title of Alabama Power Company to the property hereinafter described is subject to the lien of the Indenture dated as of January 1, 1942, as amended and supplemented (hereinafter called the Indenture), executed by Alabama Power Company (hereinafter called the Company) to Chemical Bank & Trust Company (now Chemical Bank New York Trust Company), as Trustee; and

WHEREAS, pursuant to the provisions of the first paragraph of Section 10.04 of the Indenture, the Company has requested the undersigned, as Trustee under the Indenture, to release such property from the lien of the Indenture and such other action has been taken in respect thereto as is required by the Indenture.

NOW, THEREFORE, Chemical Bank New York Trust Company (formerly Chemical Bank & Trust Company), as Trustee, under the authority of the first paragraph of Section 10.04 of the Indenture, does hereby release and quitclaim from the lien of the Indenture (subject to the exceptions and reservations set forth in the hereinafter described deed, if any), all of its right, title and interest in and to the following described property located in Shelby County, Alabama, more particularly described as follows:

All that part of the following described land which lies above that certain datum plane of 397 feet above mean sea level, as established by the United States Coast and Geodetic Survey, as adjusted in January, 1955, together with the improvements, exclusive of electric facilities, on such land:

A tract of land containing .25 of an acre, more or less, in the southwest quarter of northeast quarter (SW $\frac{1}{4}$ - NE $\frac{1}{4}$) and northwest quarter of southeast quarter (NW $\frac{1}{4}$ - SE $\frac{1}{4}$) of Section 34, Township 24 North, Range 15 East, Shelby County, Alabama, more particularly described as follows:

Commence at the southwest corner of the southwest quarter of the northeast quarter (SW $\frac{1}{4}$ - NE $\frac{1}{4}$) of Section 34, Township 24 North, Range 15 East; thence run East 200 feet to point of beginning; thence from said point of beginning North 150 feet; thence East 50 feet; thence South 183 feet, more or less, to a point of intersection with the North water's edge of Waxahatchee Creek; thence in a westerly direction along the meanderings of said Waxahatchee Creek to a point South of the point of beginning; thence North 17 feet, more or less, to the point of beginning.

The above described property is the same property described in and conveyed by deed from Alabama Power Company to Lera D. Naylor dated April 17, 1967.
