DESCRIPTIONKINGWOOD

A parcel of land situated in the Northeast 1/4 of the Southwest 1/4 of Section 26, Township 20 South, Range 3 West, Shelby County, Alabama, to be known as Lot 3 of proposed Kingwood subdivision and more particularly described as follows: Commence at the Southwest corner of said Northeast 1/4 of the Southwest 1/4, thence run in a Northerly direction along the West line of said 1/4 - 1/4 Section a distance of 77.0 feet to the Point of Beginning; thence continue in a Northerly direction along said West line a distance of 207.43 feet to a point on the Southeasternly line of a Southern Natural Gas Company Easement, thence an angle right of 75 degrees 24 minutes 29 seconds and run in a Northeasterly direction along said Easement line a distance of 54.0 feet, thence an angle right of 60 degrees 21 minutes 53 seconds and run in a Southeasterly direction a distance of 137.73 feet to a point on a curve to the left, said curve having a radius of 50 feet and subtending a central angle of 70 degrees 55 minutes 06 seconds, thence an angle right of 90 degrees to (tangent to curve) and run in a Southerly direction along the arc of said curve a distance of 61.89 feet to a point, thence an angle right of 90 degrees from (tangent to curve) and run in a Southwesterly direction a distance of 153.71 feet to the Point of Beginning.

EXHIBIT "A"

A parcel of land located in the Northeast 1/4 of the Southwest 1/4 of Section 26, Township 20 South, Range 3 West, Shelby County, Alabama, more particularly described as follows; commence at the Southwest corner of said 1/4 - 1/4 Section, thence in a Northerly direction along the West line of said 1/4 - 1/4 Section a distance of 284.43 feet, thence 75 degrees 04 minutes 29 seconds right, in a Northeasterly direction a distance of 54.0 feet to the Point of Beginning, thence continue along last described course a distance of 158.44 feet, thence 77 degrees 17 minutes 17 seconds right, in a Southeasterly direction a distance of 97.51 feet to the beginning of a curve to the right, said curve having a central angle of 92 degrees 09 minutes 30 seconds and a radius of 25.0 feet, thence along arc of said curve a distance of 40.21 feet to end of said curve, thence continue in a Southwesterly direction a distance of 17.18 feet to the beginning of a curve to the right, said curve having a central angle of 48 degrees 11 minutes 23 seconds and a radius of 25.0 feet, thence along arc of said curve a distance of 21.03 feet to end of said curve and the beginning of a curve to the left, said curve having a central angle of 67 degrees 16 minutes 17 seconds and a radius of 50.0 feet, thence along arc of said curve a distance of 53.71 feet, thence 90 degrees right, from tangent of said curve in a Northwestly direction a distance of 137.73 feet to the Point of Beginning.
