DEMARCO, JR., the receipt of which is hereby acknowledged, the said PELHAM INDUSTRIAL PARK INC., does by these presents, grant, bargain, sell and convey unto the said JOSEPH A DEMARCO, JR., the following described real estate, situated in Shelby County, Alabama:

A parcel of land located in the W 1/2 of the SE 1/4 of Section 14, Township 20 South, Range 3 West, Shelby County, Alabama, more particularly described as follows: Commence at the Southeast corner of the NW 1/4 of the SE 1/4 of said Section, thence in a Westerly direction along the South line of said 1/4-1/4 Section a distance of 56.02 feet to the point of beginning; thence continue along last described course a distance of 17.81 feet, thence 88 degrees 23 minutes right in a Northerly direction a distance of 174.72 feet, thence 48 degrees 31 minutes 30 seconds left in a Northwesterly direction a distance of 17 feet, thence 66 degrees 16 minutes 20 seconds left in a Southwesterly direction a distance of 417.09 feet, thence 83 degrees 57 minutes 23 seconds left in a Southeasterly direction a distance of 89.93 feet, thence 15 degrees 09 minutes 23 seconds left in a Southeasterly direction a distance of 122.76 feet, thence 38 degrees 06 minutes 43 seconds left in a Southeasterly direction a distance of 328.62 feet, thence 108 degrees 08 minutes 30 seconds left in a Northerly direction a distance of 276.92 feet to the point of beginning.




