QUITCLAIM DEED

KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the sum of Five Hundred Ninety-five and no/100-----Dollars

in hand paid to the undersigned, the receipt whereof is hereby acknowledged, the undersigned hereby releases, quitclaims, grants, sells, and conveys to

Alabaster Water and Gas Board

(hereinafter called Grantee), all our right, title, interest, and claim in or to the following described real estate, situated in Shelby

County, Alabama, to-wit:

Commence at an old 2" iron pipe, being the Northeast corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 12, Township 21 South, Range 3 West as shown by survey of Walter Schoel in 1935; thence run West along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ section a distance of 1263.70 feet to an old iron, being the point of beginning of the parcel herein described; thence continue in the same Westerly direction 145.52 feet to a point marked by an old iron; thence turn an angle of 111 deg. 43 min. to the left and run in a Southerly direction 157.30 feet to a point marked by an old iron; thence turn an angle of 95 deg. 04 min. to the left and run in a Northeasterly direction 117.92 feet to a point marked by an old iron; thence turn an angle of 74 deg. 06 min. to the left and run in a Northerly direction 94.72 feet to the point of beginning.
