 and for the overhead and underground communication service, upon, over,
 under and across the following described land, situated in Shelby
 County, Alabama:

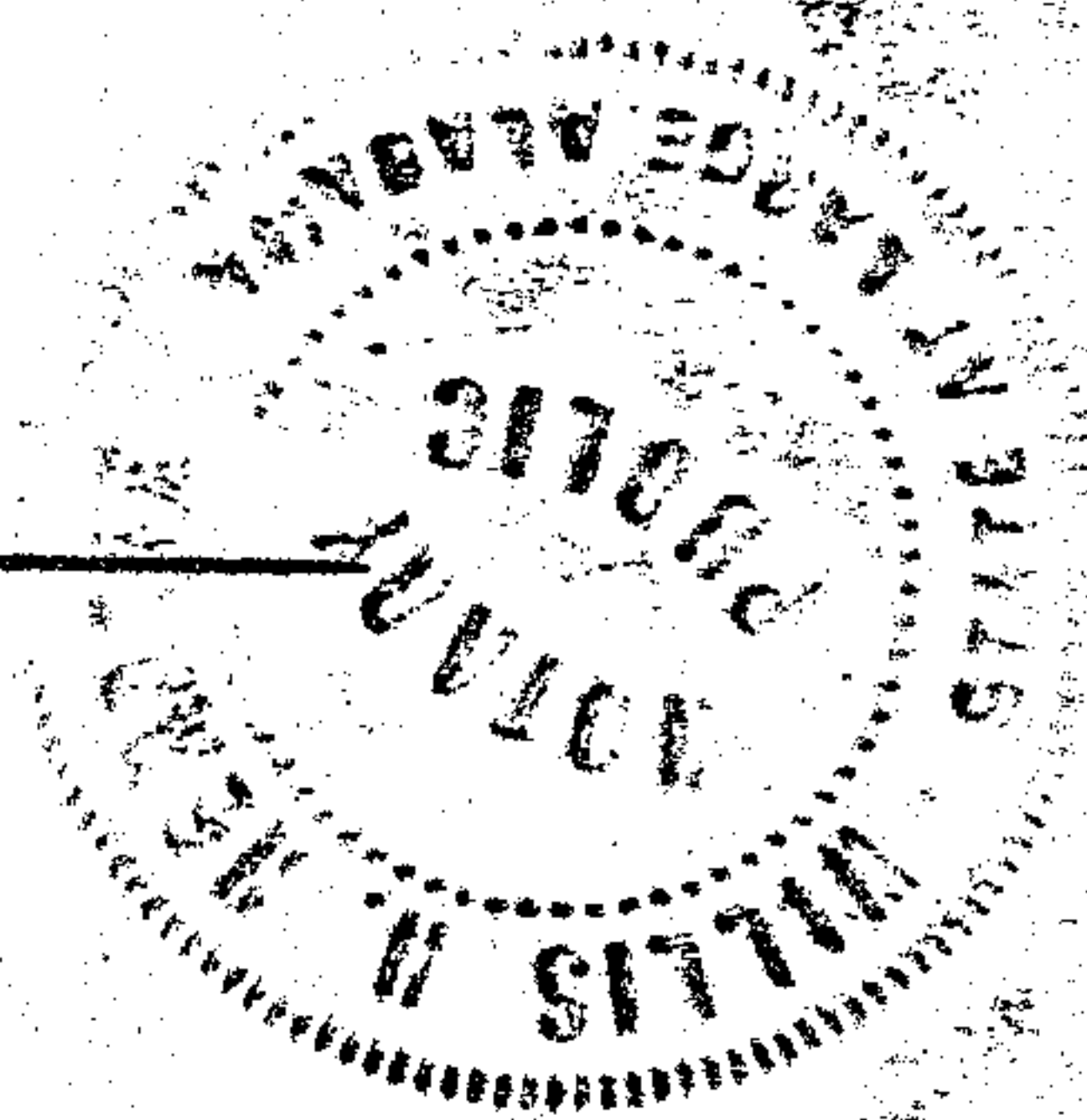
