(herein referred to as grantors) do grant, bargain, sell and convey unto

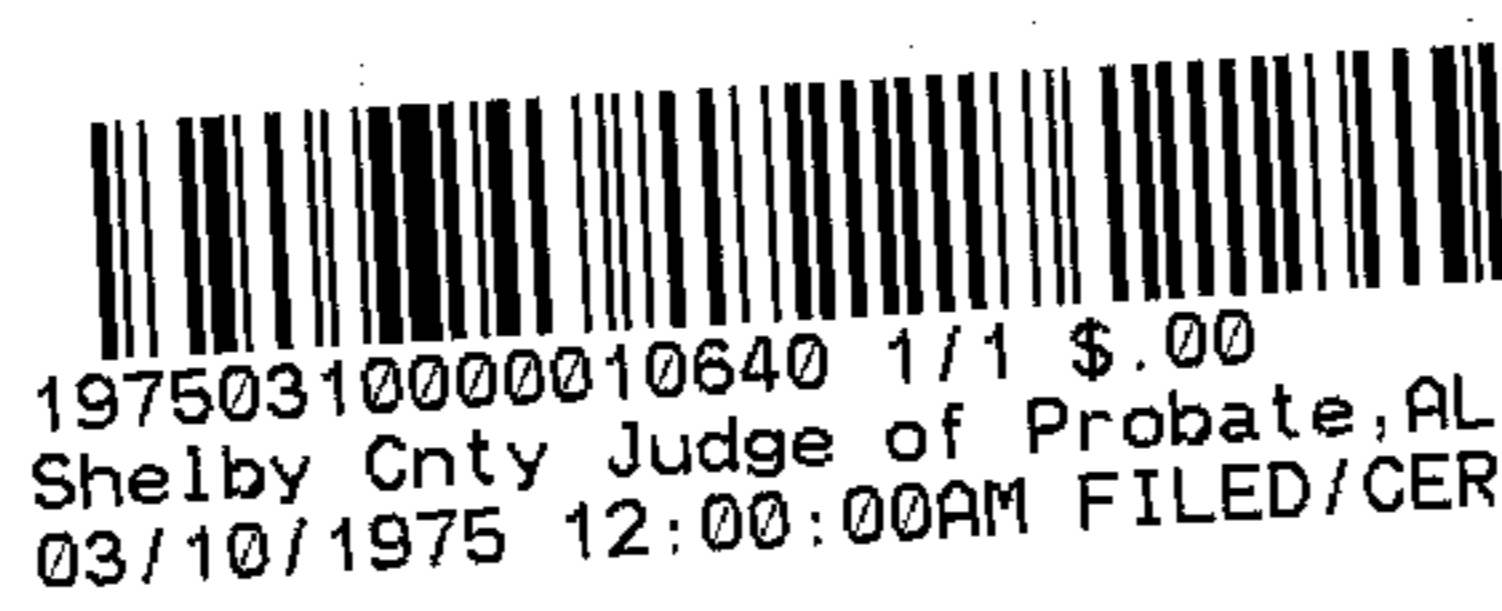
Terry P. Crumpton and wife, Sara Crumpton

A part of the NE 1/4 of the NE 1/4, Section 4, Township 20, Range 1 West, more particularly described as follows: Commence at the SW corner of said NE 1/4 of NE 1/4 of said Section 4 for point of beginning and run thence in an easterly direction along the southern boundary thereof a distance of 528 feet to a point; thence turn to the left and run northerly parallel with the western boundary of said 1/4 1/4 Section a distance of 825 feet to a point; thence turn to the left and run westerly parallel with the southern boundary of said 1/4 1/4 Section a distance of 528 feet to a point on the western boundary thereof; thence turn to the left and run southerly along the western boundary of said 1/4 1/4 Section a distance of 825 feet to the point of beginning.
