That in consideration of Ten Dollars (\$10.00) and other good and valuable consideration

including love and affection,

to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

Gertrude L. Kirkley, a widow

(herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

Gertrude Kirkley Hill

(herein referred to as grantee, whether one or more), the following described real estate, situated in
Shelby County, Alabama, to-wit:

A lot having a frontage of 210 feet on Broad Street in the City of Montevallo, Alabama, described as follows: Commencing at a point on the Northwest side of Broad or Main Street about 170 feet Northeast of the Northeast side of Bloch Street; run thence Northeasterly along Main Street 70 yards; thence Northwesterly parallel or nearly parallel with Bloch Street 70 yards to Valley Street; thence Southwest parallel or nearly parallel to Main Street or Broad Street 70 yards; thence Southeast parallel or nearly parallel to Bloch Street 70 yards to the point of beginning, containing in all about one acres, and being known as the "Clara Goodman Place" in the City of Montevallo, which was conveyed to J. M.
