in hand paid by Cecil Garnett Wade and wife Betty E. Wade


the receipt whereof is acknowledged we the said C. M. Wade and wife Stella Wade

do grant, bargain, sell and convey unto the said Cecil Garnett Wade and wife Betty E. Wade

the following described real estate, situated in Shelby

County, Alabama, to-wit: Part of the E 1/2 of SW 1/4 of Section 22, Township 20 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows:

From the southwest corner of the SE 1/4 of SW 1/4 of said section, run in an easterly direction along the south line of said section for a distance of 610.84 feet to the point of beginning, thence turn an angle to the left and run in a northwesterly direction for a distance of 1,461.72 feet, thence turn an angle to the right of 90° and run in a northeasterly direction for a distance of 70. feet, thence turn an angle to the left of 18°-00' and run in a northeasterly direction for a distance of 60. feet, thence turn an angle to the left of 17°-24' and run in a northeasterly direction for a distance of 89.54 feet. thence turn an angle to the right of 130°-20' and run in a southerly direction for a distance of 1,545.33 feet to a point on the south line of said Section 22, thence turn an angle to the right of 91°-25' and run in a westerly direction along said south line of said Section 22 for a distance of 67.72 feet, more or less, to the point of beginning, containing 4.48 acres, more or less. 
