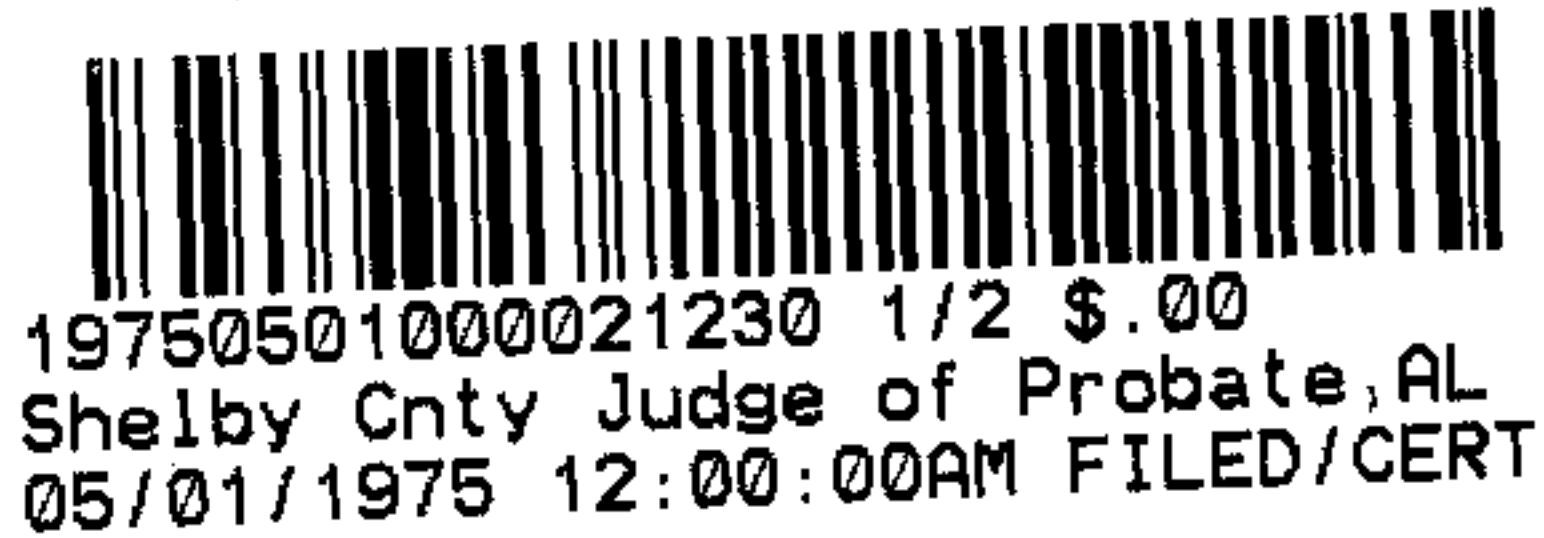

DEED OF CORRECTION

Whereas, the undersigned Martin Marietta Corporation, a corporation (Martin Marietta), by deed dated August 15<sup>th</sup>, 1974, and recorded in the office of the Judge of Probate of Shelby County, Alabama in Deed Book 288, page 480 conveyed the real estate described therein to H. Sherman Holland, Jr. (Grantee), but by mistake referred to the Grantee as "Sherman Holland"; and
