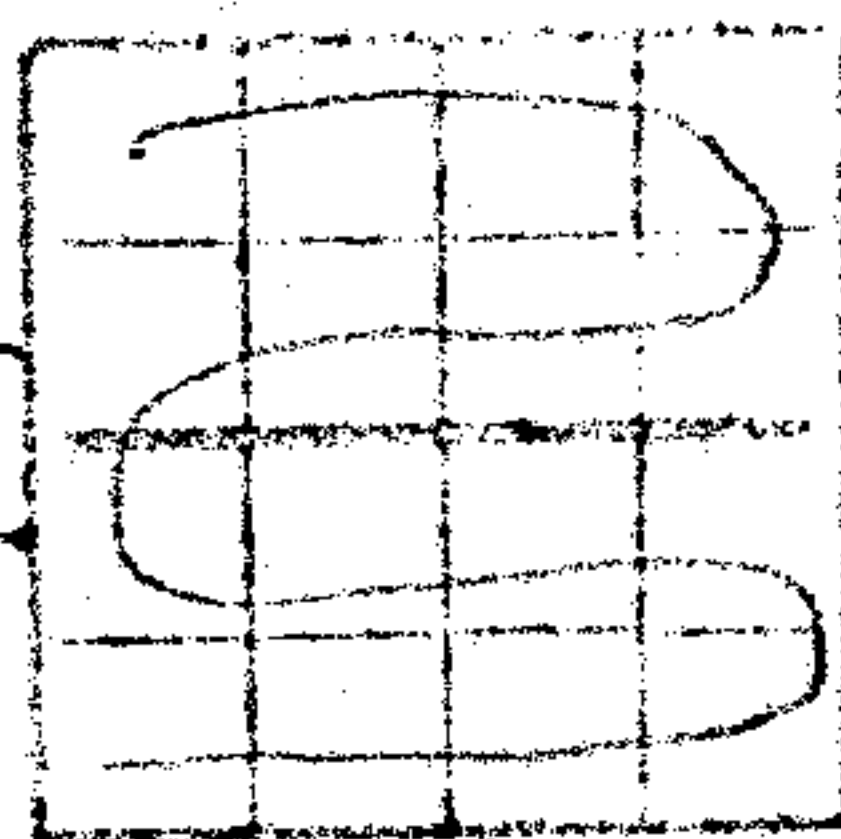

agreement dated the 4th day of October 1930, by which the Power Company
has the right to construct, operate and maintain electric power lines under
and across the rights of way and easements of the Gas Company;

WHEREAS, the Power Company desires the right to construct,
operate and maintain a power line under and across the right of way of the
Gas Company at the following two locations:

At a point two feet inside the west line of Alexander Court
of Kingwood Subdivision, such point being 77 feet northeast
of SNG Marker #1, also at a point two feet inside the west
line of King George Drive of Kingwood Subdivision, such point
being 446 feet northeast of said SNG Marker #1, both crossings
located in Section 26, Township 20 south, Range 3 west, Shelby
County, Alabama and are shown in red on Alabama Power Company's
Drawing #B-462-7, marked Exhibit "A" attached hereto and made
a part hereof.

NOW THEREFORE, in consideration of the premises and of their

mutual covenants and agreements, the parties hereto have mutually covenanted
and agreed as follows: The Gas Company hereby grants to the Power Company,
insofar as the Gas Company has any right or title to make such grant, the
right to construct, operate and maintain the power line crossing as shown
on the print hereto attached and marked Exhibit "A", but subject, however,
to all the terms and conditions of the aforesaid agreement dated October 4,
1930, and the parties agree that all and singular the provisions of said
agreement shall apply to the transmission line crossing herein described,
in the same manner and to the same extent as though such crossing had been
included in the said agreement.
