THIS AGREEMENT, Made and entered into this 1st day of Indrely 19 75, by and between the SEABOARD COAST LINE RAILROAD COMPANY, a Virginia corporation, hereinafter referred to as SCL, and the CITY OF PELHAM, a municipal corporation under the laws of the State of Alabama, hereinafter referred to as the City, WITNESSETH:

WHEREAS, by an indenture dated May 12, 1966, the former Atlantic Coast Line Railroad Company, now Seaboard Coast Line Railroad Company, granted to the City, its successors and assigns, an easement for maintaining and operating a well on certain land situate, lying and being in the NW4 of the NW4 of Section 24, Township 20 South, Range 3 West, at Pelham, Shelby County, Alabama, as particuarly described in said indenture to which reference is hereby made; and

WHEREAS, effective July 1, 1967, the former Atlantic Coast Line Railroad Company merged with the former Seaboard Air Line Railroad Company, pursuant to the authority of the Interstate Commerce Commission, F/D 21215, the surviving corporation being the Seaboard Coast Line Railroad Company, a Virginia corporation; and and the state of the state

WHEREAS SCL desires, and the City is willing, that said indenture dated May 12, 1966 be terminated;

NOW THEREFORE the parties hereto hereby agree that effective on the /st day of Murch, 1975, said indenture dated May 12, 1966, shall be and is hereby terminated.

It is understood and agreed that this termination agreement shall not be binding until it has been authorized or ratified by a proper ordinance or resolution of the City Council of the City of Pelham, Alabama, a certified copy of which ordinance or resolution is attached hereto and made part of this agreement.
