
KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned,

County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which right-of-way shall be feet in width on \_\_\_\_\_\_\_ side of the center line of said road, as it is now located and staked out by the Highway Department or as much of our lands as is required to make a \_\_\_\_\_\_ foot right-of-way across our lands, said right-of-way herein conveyed being more particulary described as follows, to-wit: And as shown on the right-of-way map of Project No.\_\_\_\_\_\_ as recorded in the office of the Judge of Probate of Shelby County.

Commence at the southwest corner of the SW4 of SE4, Section 16, T 19 S, R 2 W and run east along the south boundary line of said quarter quarter section a distance of 15.0 feet to a point, thence turn an angle of 91° 14' to the left and run a distance of 392.03 feet to the point of beginning in the center of Marcal Road, thence turn an angle of 82° 21' to the right and run northeasterly along the center of said Marcal road a distance of 620.98 feet to a point; thence continue northeasterly along the center of said Marcal road along a curve to the left (concave northwesterly) and having a radius of 173.53 feet a distance of 169.24 feet to a point; thence continue northeasterly along the center of said Marcal Road a distance of 136.15 feet to a point; thence run northeasterly along the center of said Marcal Road along a curve to the right (concave southeasterly) and having a radius of 1095.84 feet a distance of 335.61 feet to a point; thence run along the center of said Marcal Road a distance of 273.80 feet to a point; thence turn an angle of 14° 32' to the left and run along the center of said Marcal Road a distance of 146.61 feet to the point of ending on the west right of way line of the McGuire Lake Road.
