That in consideration of One Dollar and other good and valuable considerations

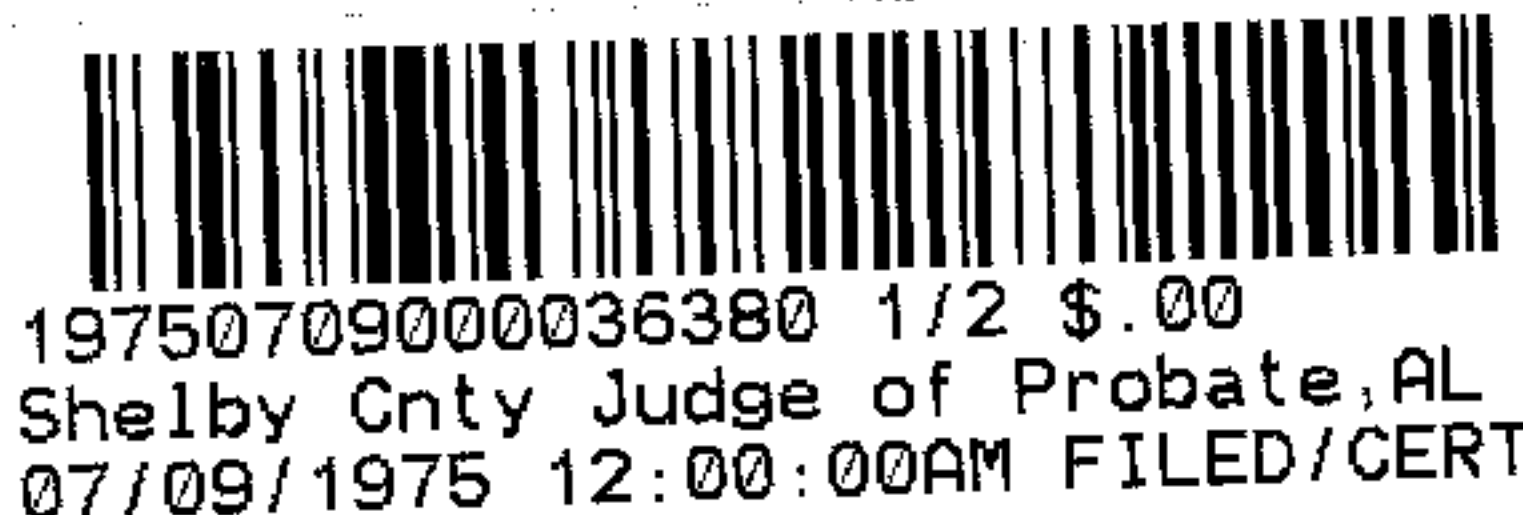
