KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of Five Thousand Forty and no/100 Dollars (\$5,040.00), to the undersigned grantors, Dollie C. Roberts, a widow, in hand paid by Kimberly-Clark Corporation, the receipt whereof is hereby acknowledged, I, the said Dollie C. Roberts, do hereby grant, bargain, sell and convey unto the said Kimberly-Clark Corporation, all of the pine sawtimber and pulpwood timber located on the following property:


The NW $\frac{1}{4}$ of NW $\frac{1}{4}$ and the N $\frac{1}{2}$ of SW $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 30, Township 20 South, Range 1 East, Shelby County, Alabama, together with full and free right of ingress and egress to and from said land at any and all times until the expiration of 365 days from the date of the execution of this deed, for the purpose of cutting and removing said timber, but after said time, grantee shall have no further rights or interest in said land or timber and at the expiration of said time, said land and all uncut timber shall revert to the grantor herein.

It is further understood and agreed that the grantee shall have the right to use existing private roads and has the right to build such temporary roads and other devices as may be necessary or useful to the grantee for the purpose of cutting and removing the timber.

And I do for myself and for my heirs, executors and administrators covenant with the said Kimberly-Clark Corporation, its successors and assigns, that I am lawfully seized of said premises in fee simple; that it is free from all encumbrances and I have a good right to sell and convey said timber as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to the said Kimberly-Clark Corporation, its successors and assigns against the lawful claims of all persons.
