 Shelby County, Alabama, to-wit:

 shall take as tenants in common.


And said Roy Martin Construction, Inc. does for itself, its successors

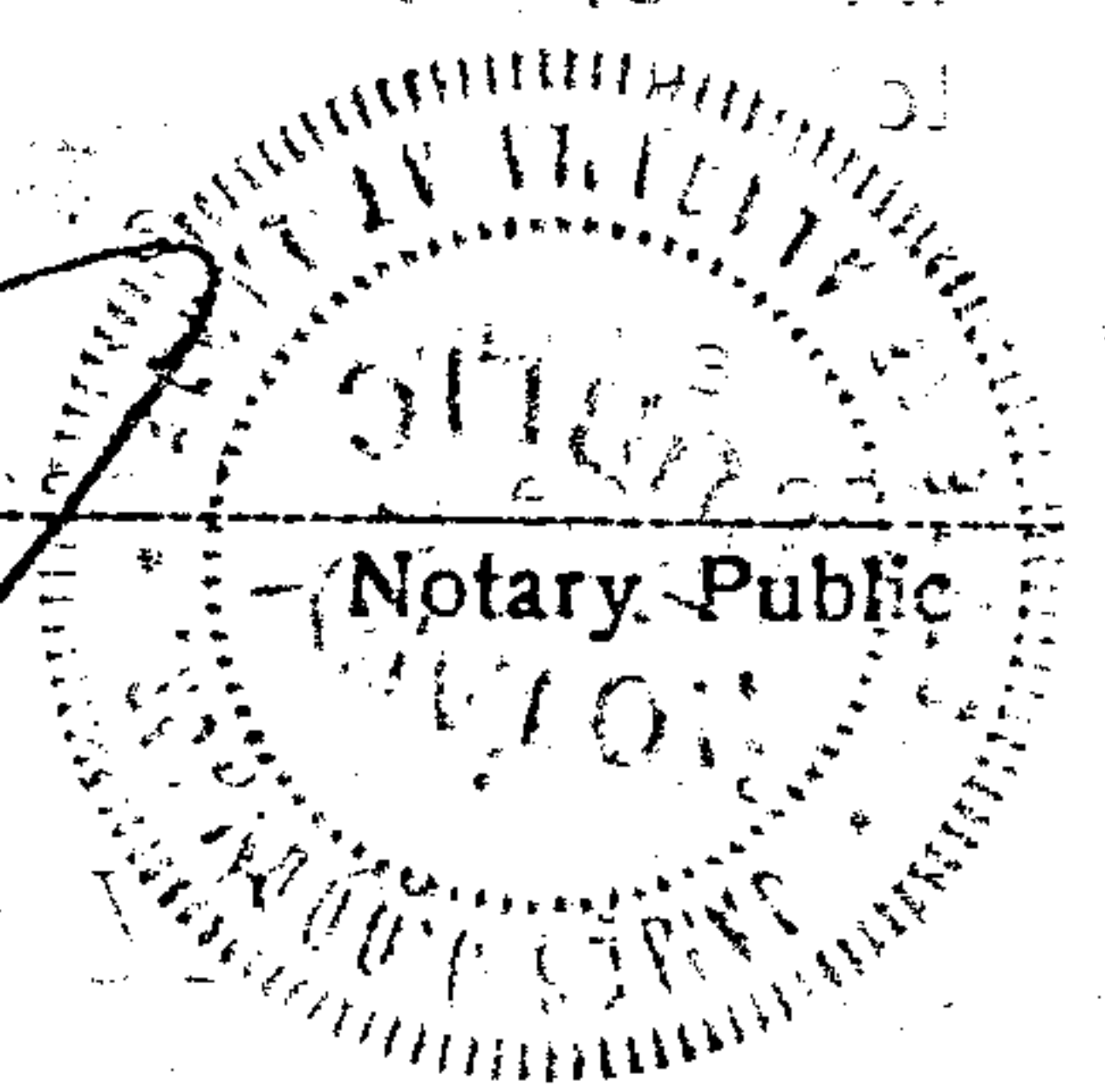
