I, the undersigned, hereby certify that Alabama Power Company neither claims the right nor proposes to construct any additional lines for the transmission of electricity over or across the lands described herein below, under the authority granted in the following right of way permits:

1. Longview - Saginaw Lime Works, dated March 24, 1936, recorded in Deed Book 101, Page 97, in the Office of the Judge of Probate of Shelby County, Alabama.
2. Longview - Saginaw Lime Works, dated June 16, 1937, recorded in Deed Book 103, Page 57, in the Office of the Judge of Probate of Shelby County, Alabama.
3. Longview - Saginaw Lime Works, Inc., dated February 7, 1938, recorded in Deed Book 103, Page 486, in the Office of the Judge of Probate of Shelby County, Alabama.
4. Longview - Saginaw Lime Works, Inc., dated October 25, 1946, recorded in Deed Book 127, Page 305, in the Office of the Judge of Probate of Shelby County, Alabama.
5. Longview Lime Corporation, dated January 19, 1950, recorded in Deed Book 141, Page 418, in the Office of the Judge of Probate of Shelby County, Alabama.
6. Longview Lime Corporation, dated July 12, 1954, recorded in Deed Book 169, Page 328, in the Office of the Judge of Probate of Shelby County, Alabama.

The purpose for which such right of way permits were acquired was for distribution lines which were installed and subsequently removed or to be removed from property described below in Shelby County, Alabama.

A parcel of land in the North Half of the Southeast Quarter of the Southwest Quarter of Section 7, Township 21 South, Range 2 West, Shelby County, Alabama, said parcel being more particularly described as follows:

From the Northwest corner of the Southwest Quarter of the Southwest Quarter of said Section 7, looking South along the West line of said quarter-quarter section, turn an angle to the left of 80 degrees 41 minutes and run Southeasterly for a distance of 1877.08 feet to the point of beginning of the property herein described; thence turn an angle to the left of 28 degrees 33 minutes and run Northeasterly for a distance of 406.32 feet; thence turn an angle to the right of 90 degrees and run Southeasterly for a distance of 70 feet; thence turn an angle to the right of 90 degrees and run Southwesterly for a distance of 435.3 feet; thence turn an angle to the right of 90 degrees and run Northwesterly for a distance of 70 feet to a point which is 28.98 feet from the point of beginning; then go in a Northeasterly direction in a straight line 28.98 feet to the point of beginning.
