KNOW ALL MEN BY THESE PRESENTS,

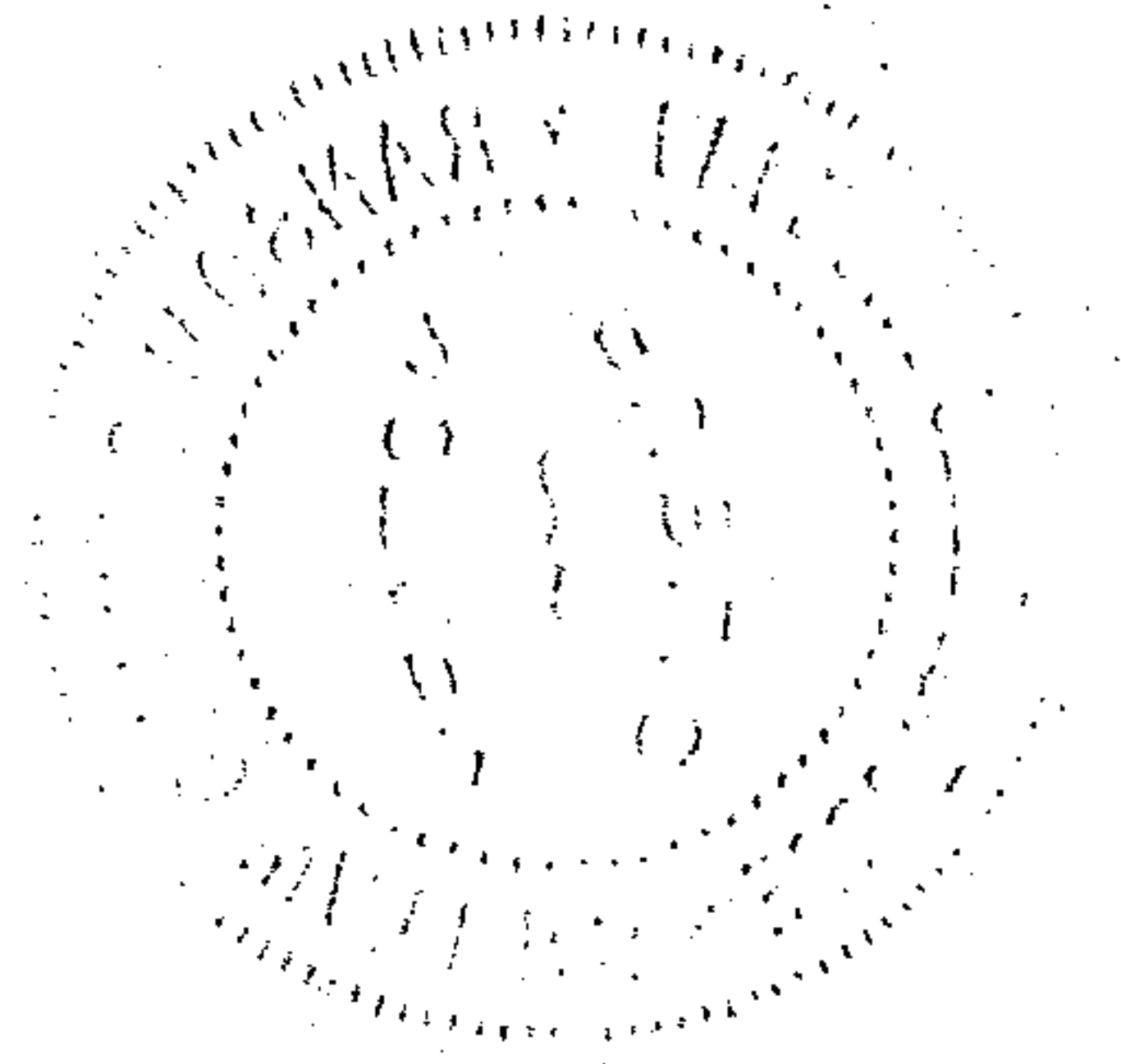
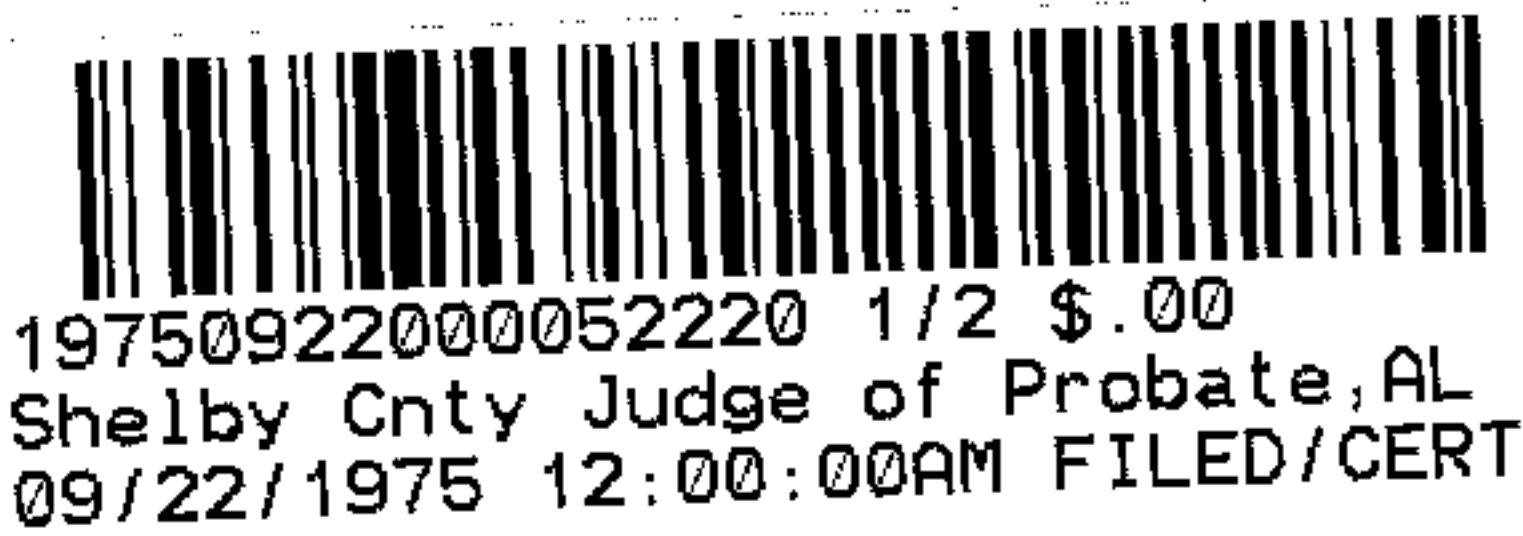
That in consideration of TEN DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION

to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Lottie Moody, a widow; Elvin Waters and wife, Joyce Waters; Freddie Lee Moody and wife, Dell Moody; W. T. Moody and wife, Dixie Lee Moody; Leighton Joe Moody and wife, Bonnie Moody (herein referred to as grantors) do grant, bargain, sell and convey unto

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

Commence at the NE corner of the NE $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 4, Township 24 North, Range 13 East, run west along forty line a distance of 271 feet to an iron pipe or forty line for the point of beginning, continue West along forty line a distance of 271 feet to an iron pin; thence run south and parallel with east forty line 944 feet or to north R.O. W. line of Highway No. 20; thence run East and along R. O. W. 271 feet to a point; thence north and parallel with east forty line 944 feet or to the point of beginning, a parcel of land containing approximately six acres.

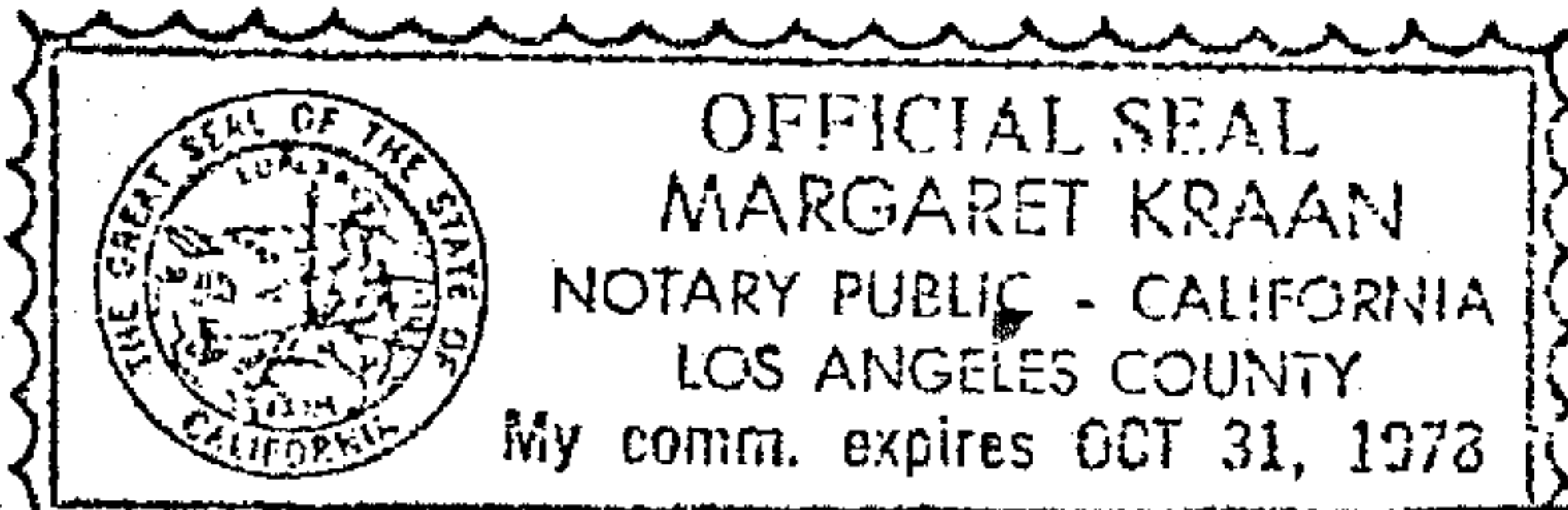

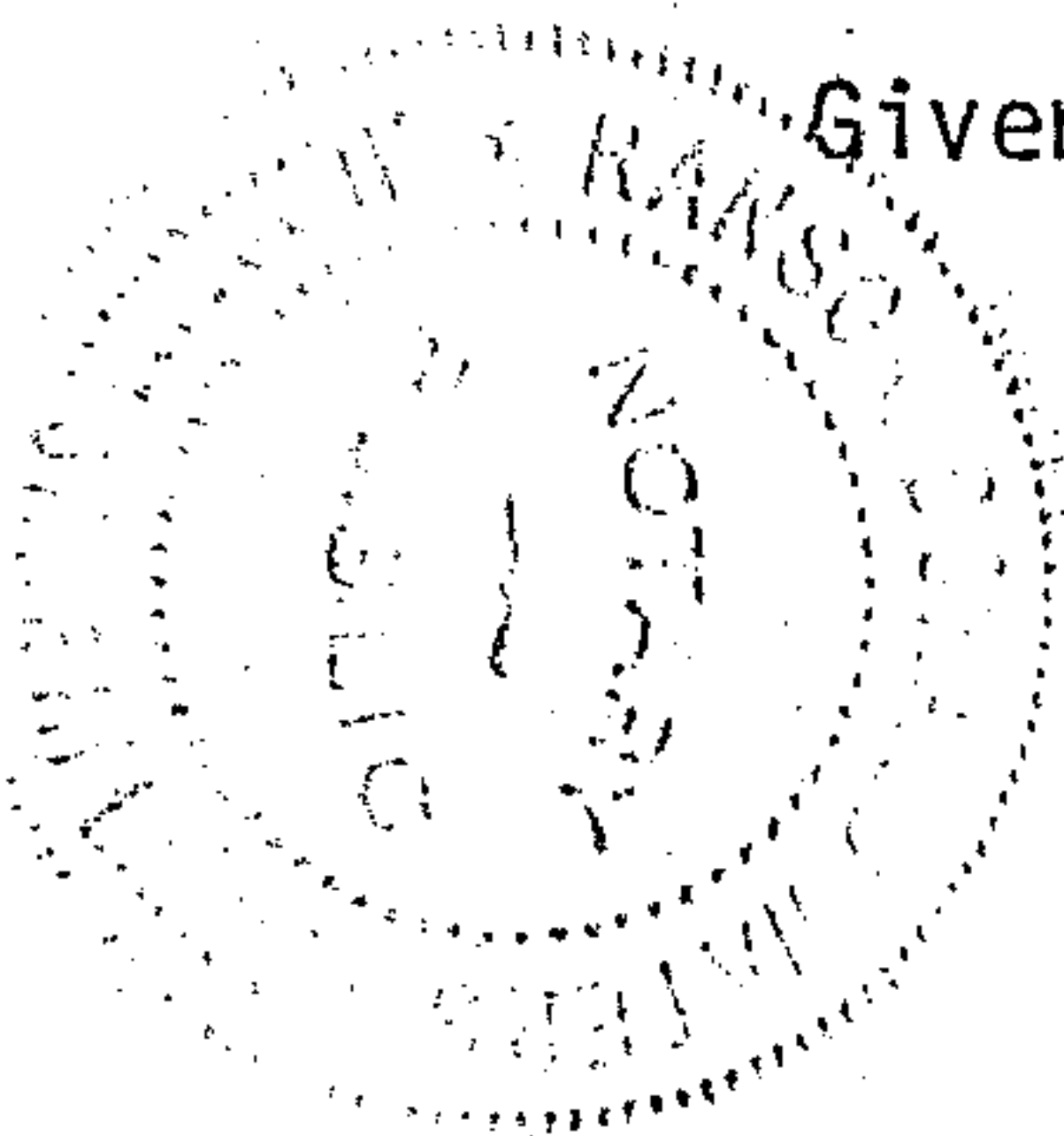
