KNOW ALL MEN BY THESE PRESENTS, That I, the under-  
signed, Annie Creel Adams, (hereinafter called "grantor"), in  
and for the consideration of ten dollars (\$10.00) in hand paid  
by Cahaba Girl Scout Council, Inc., (hereinafter called "gran-  
tee") the receipt whereof is hereby acknowledged and for the  
further consideration of the benefit accruing to me from the  
construction or improvement of a road through my lands in  
Shelby County, do hereby give, grant, bargain, sell and convey  
unto the grantee, its successors or assigns, a right-of-way  
hereinafter described, over and across our said lands in Shelby  
County, Alabama, for a road; which right-of-way shall be thirty  
(30) feet in width on either side of the center line of said  
road, the center line of said right-of-way herein conveyed  
being more particularly described as follows, to-wit:

AT THE NE. COR OF THE SW 1/4 OF THE NW 1/4

DIST. OF 217.3 FT TO A PT: THC WITH DEF  
ANGLE OF 3°31' TO THE LEFT A DIST. OF 205.7

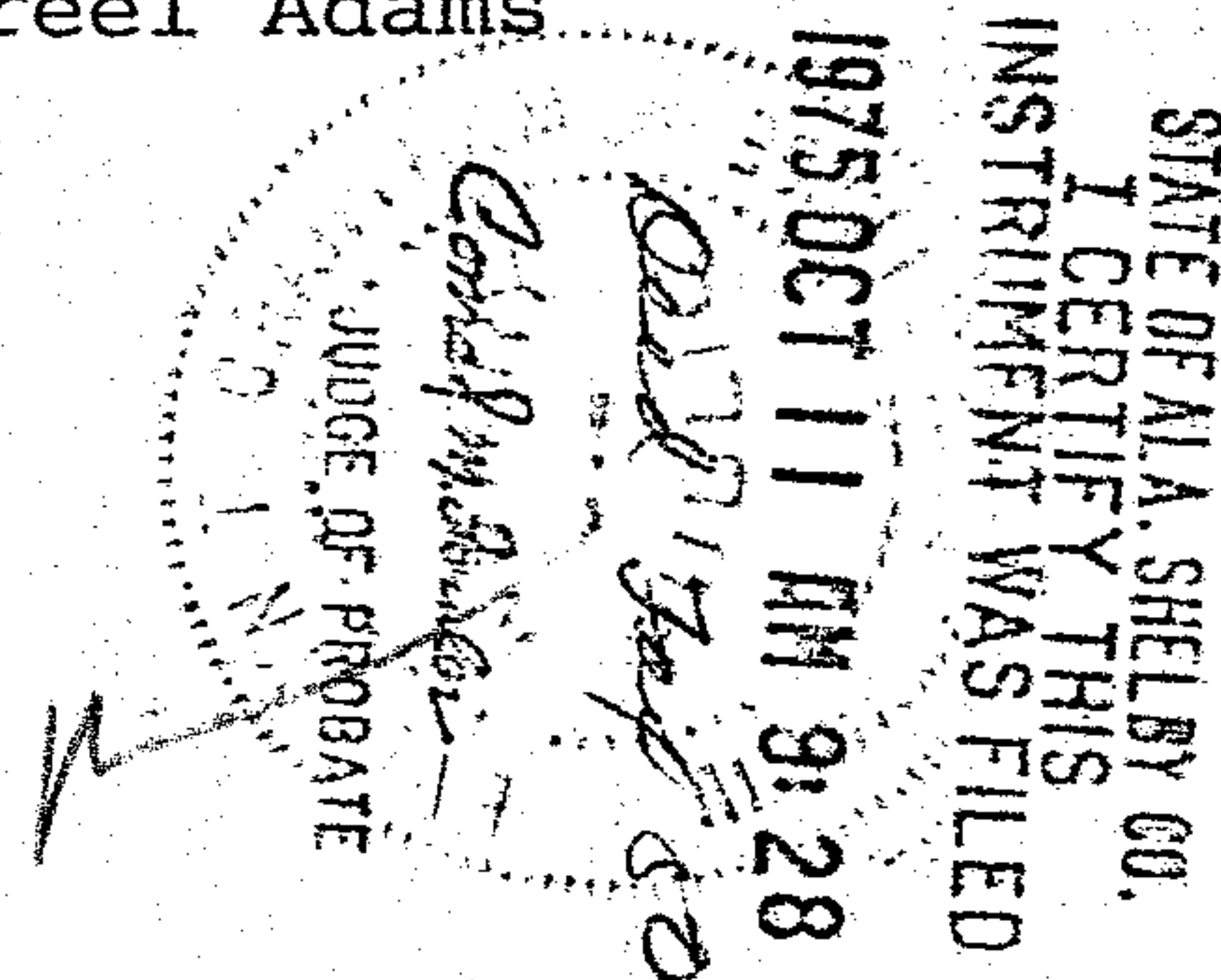
