KNOW ALL MEN BY THESE PRESENTS, That we, the under-  
signed, Richard H. Cord and wife, Virginia F. Cord, and the  
First Christian Church of Birmingham, Alabama, Inc., (hereinafter  
called "grantors") in and for the consideration of Ten Dollars  
(\$10.00) in hand paid by Cahaba Girl Scout Council, Inc. (herein-  
after called "grantee") the receipt whereof is hereby acknowledged  
and for the further consideration of the benefit accruing to us  
from the construction or improvement of a road through our lands  
in Shelby County, do hereby give, grant, bargain, sell and convey,  
to the extent of their interest therein, unto the grantee, its  
successors or assigns, a right-of-way hereinafter described, over  
and across our said lands in Shelby County, Alabama, for a road;  
which right-of-way shall be thirty (30) feet in width on either  
side of the center line of said road, the center line of said  
right-of-way herein conveyed being more particularly described as  
follows, to-wit:

To locate the point of beginning, commence at  
the Northwest Corner of the Northeast  $\frac{1}{4}$  of the  
Southwest  $\frac{1}{4}$  of Section 24, Township 19 South;  
Range 1 West Shelby County, Alabama, thence East  
along the North Line of said Northeast  $\frac{1}{4}$  a distance  
of 369.9 feet to a point which point is the point  
of beginning, thence with a deflection angle of 6  
degrees 25 minutes to the left, run a distance of  
253.1 feet to a point, thence with a deflection  
angle of 15 degrees 56 minutes to the right run a  
distance of 53.0 feet to a point which point is 15  
feet measured northwardly from the North line of  
the Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of said Section  
24; thence continue with a 45 foot strip of land, 30  
feet North of and 15 feet South of a line described  
as beginning at the above last described point,  
thence with a deflection angle of 9 degrees 31  
minutes to the left run eastwardly parallel to and  
15 feet North of said North line a distance of  
648.5 feet to a point on the West Right of Way Line  
of an existing county Road.




To locate the Point of Beginning, commence at the Northeast corner of the Northwest  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of Section 24; Township 19 South; Range 1 West, Shelby County, Alabama. Thence West along the North line of said Northwest  $\frac{1}{4}$  a distance of 90.8 feet to a point which point is the point of beginning, thence with a deflection angle of 147 degrees 37 minutes to the left run a distance of 87.1 feet to a point, thence with a deflection angle of 25 degrees 13 minutes to the left run 120.0 feet to a point; thence with a deflection angle of 20 degrees 34 minutes to the left run 213.0 feet to a point; thence with a deflection angle of 7 degrees 27 minutes to the right run 61.5 feet to a point, which point is 369.9 feet measured westwardly, along the North line of the Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of Section 24, Township 19 South, Range 1 West from the Northwest Corner of said Northeast  $\frac{1}{4}$ .


A strip of land 15 feet in width off the North side of the Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  beginning at the Northeast Corner of said Northeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  and running Westwardly a distance of 648.5 feet.

The grantors reserve the right for themselves, their heirs, successors and assigns, to use the above-described right-of-way jointly with the grantee.

TO HAVE AND TO HOLD by the grantee, its successors and assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the grantee aforesaid, and all of its employees and officers, from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
