## SUBORDINATION OF MORTGAGE AGREEMENT

A. That the purchase money mortgage recorded at Mortgage Book 349. Page 125, on \_\_\_\_\_ day of September, 1975, be and is hereby subordinated, made junior and inferior to that certain mortgage from E. W. Quiggle and wife, Hazel Quiggle, to Jefferson Federal in the amount of Fifty-five thousand dollars (\$55,000.00) and recorded at Mortgage Book 349 Page, 57. In the event that a mortgage is held by Jefferson Federal for the construction of said improvements on the real property referred to in paragraph 2 and at a later time said mortgage is transferred to a long term mortgage then the purchase money mortgage of the vendors shall be subordinate, inferior, and junior to that said mortgage.
