6, Page 40, in the Probate Office of Shelby County, Alabama.

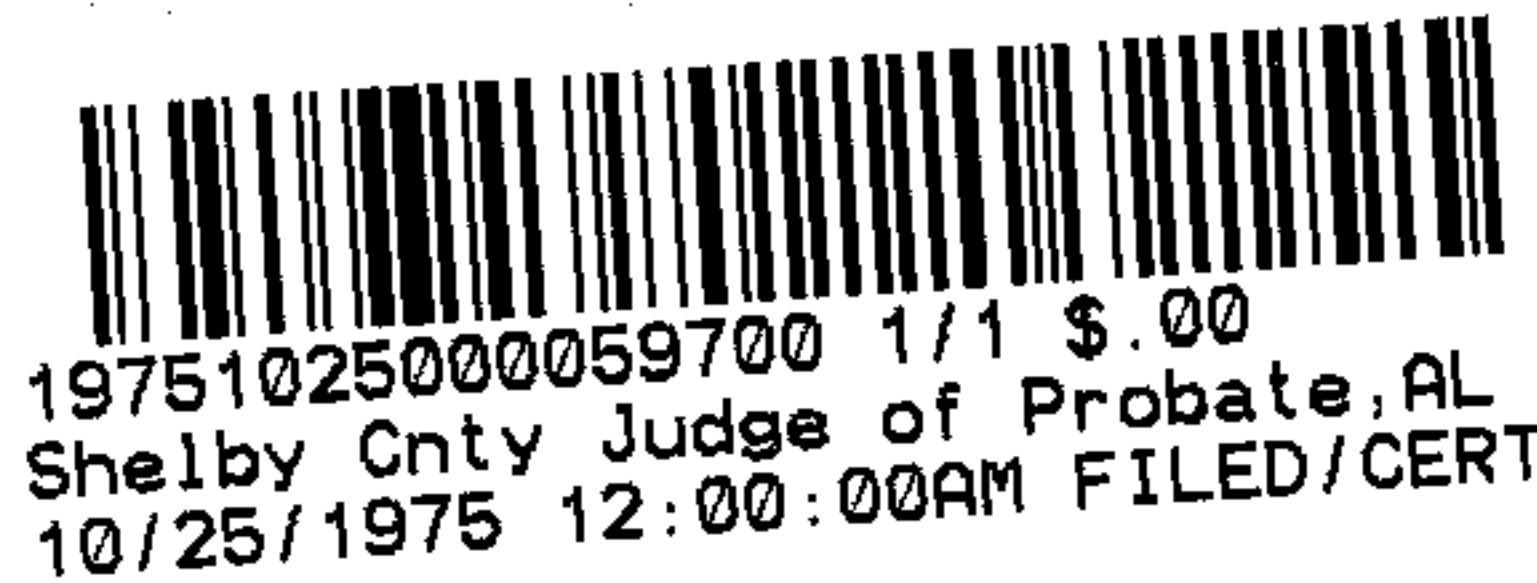
