the receipt whereof is acknowledged, the said

does by these presents, grant, bargain, sell, and convey unto the said

Alvin P. Fulton and Margaret A. Fulton

as joint tenants, with right of survivorship, the following described real estate, situated in
Shelby

County, Alabama, to-wit:

A parcel of land located in the Northeast 1/4 of the Northeast 1/4 of Section 27,
Township 20 South, Range 4 West, Shelby County, Alabama, more particularly described
as follows: Commence at the Southeast corner of said 1/4-1/4; thence run West along
Quarter Section line for a distance of 114.31 feet to the Point of Beginning; thence
continue in the same direction for a distance of 620.82 feet to the East right of way
of Southern Railroad; thence right, an angle of 125 degrees 53 minutes, for a distance
of 347.60 feet; thence turn right, an angle of 95 degrees 15 minutes, for a distance
of 236.56 feet; thence turn left, an angle of 27 degrees 33 minutes, for a distance
of 115.06 feet; thence turn left, an angle of 15 degrees 32 minutes, for a distance
of 153.65 feet to the West side of a county road; thence turn right, an angle of
