That in consideration of One Dollar and exchange of property DOLLARS

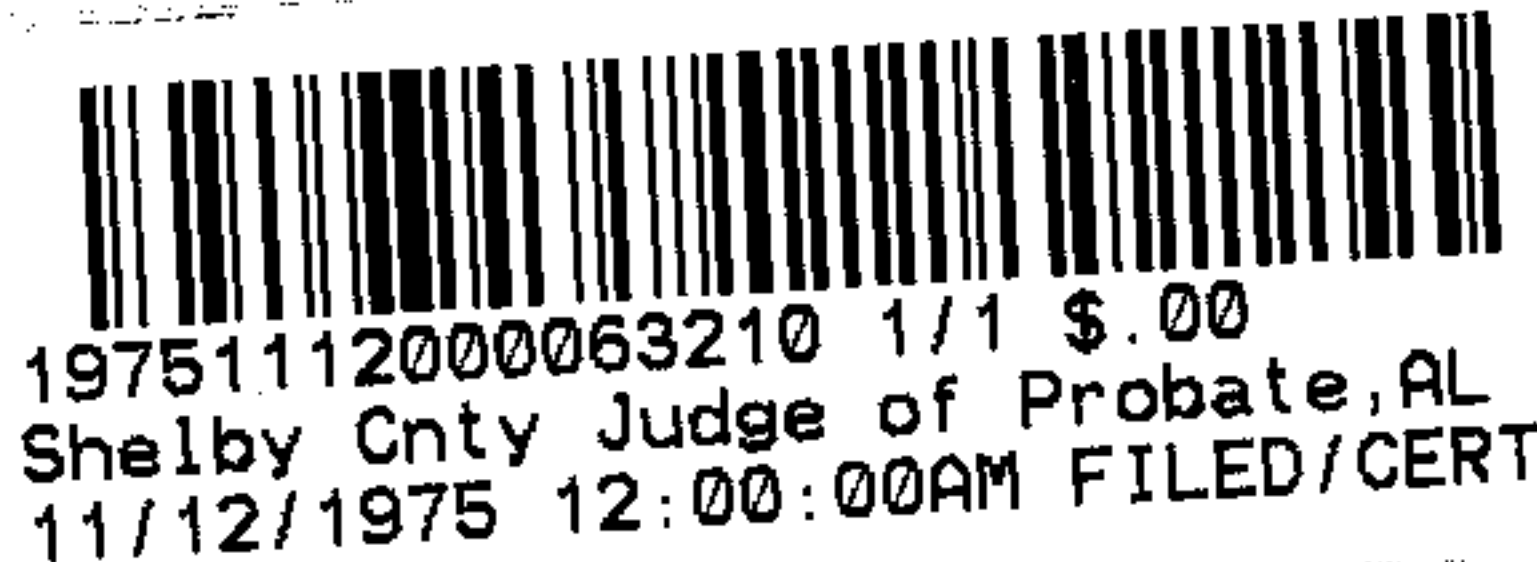
