(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated

in Shelby County, Alabama to-wit:

A lot in the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 1 and the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ Section 12, Township 21 South, Range 1 East, described as follows: Commence at the Northeast corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 1, Township 21 South, Range 1 East, thence run West along the North line of said $\frac{1}{4}$ - $\frac{1}{4}$ a distance of 504.10 feet; thence turn an angle of 103 deg. 32 min. to the left and run a distance 578.90 feet; thence turn an angle of 24 deg. 18 min. to the right and run a distance of 378.49 feet; thence turn an angle of 13 deg. 12 min. to the right and run a distance of 180.00 feet to the point of beginning; thence turn an angle of 90 deg. 00 min. to the left and run a distance of 200.00 feet; thence turn an angle of 90 deg. 00 min. to the right and run a distance of 200.00 feet; thence turn an angle of 59 deg. 15 min. 46 sec. to the right and run a distance of 188.80 feet to a point on the East R/W line of a county highway; thence turn an angle of 109 deg. 36 min. 14 sec. to the right and run along said R/W a distance of 185.34 feet; thence turn an angle of 10 deg. 10 min. to the right and continue along said Highway R/W a distance of 114.66 feet to the point of beginning. Situated in the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$, Section 1, and the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 12, Township 21 South, Range 1 East.
