WARRANTY DEED, JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

STATE OF ALABAMA

COUNTY OF SHELBY

KNOW ALL MEN BY THESE PRESENTS, That in consideration of One Hundred and No/100 Dollars and other good and valuable consideration to the undersigned grantors in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, Arthur Earl McIlwain, a single man; John Wesley McIlwain and wife, Lois C. McIlwain ; Janie McIlwain, a widow; Irene McHenry, a widow; Theodore A. McIlwain, Jr., an unmarried man; Marion Cain and husband, William Cain; and Mary E. Thomas and husband, Charles Thomas, (herein referred to as grantors) do grant, bargain, sell and convey unto Herbert Epperson and wife, Barbara Epperson (herein referred to as Grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

A portion of the SW $\frac{1}{4}$  of the NE $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 14, Township 22 South, Range 1 West, more particularly described as follows; Begin at the SW corner of the said quarter-quarter-quarter and run easterly along the south side of said quarter-quarter-quarter for 382.54 ft. to a point in the centerline of the old Columbiana dirt road, then turn an angle of 22 deg. 04 min. 25 sec. to the left and run along the centerline of the said road for 179.55 ft., then turn an angle of 10 deg. 36 min. 39 sec. to the right and run along the centerline of the said road for 130.50 ft. to a point on the east side of the said quarter-quarter-quarter, then turn an angle of 77 deg. 33 min. 56 sec. to the left and run northerly along the east side of the said quarter-quarter-quarter for 574.53 ft., then turn an angle of 90 deg. 37 min. 51 sec. to the left and run westerly along the north side of said quarter-quarter-quarter for 674.05 ft., then turn an angle of 89 deg. 16 min. 18 sec. to the left and run southerly along the west side of said quarter-quarter-quarter for 671.99 ft. back to the point of beginning. The above described land is subject to the right of way of Shelby County Road #307, that R.O.W. being 80 ft. wide.

TO HAVE AND TO HOLD to the said Grantees for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

And we do for ourselves and for our heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and our heirs, executors and administrators shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.
