WARRANTY DEED, Jointly for Life With Remainder to Survivor

STATE OF ALABAMA )

KNOW ALL MEN BY THESE PRESENTS,

SHELBY COUNTY )

That in consideration of Seven Thousand Dollars to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt of a note and mortgage for which is acknowledged, we,

William A. Yon and wife, Elizabeth M. Yon; Christopher D. Potter and wife, Janet Potter; Philip Mohring and wife, Hunter Mohring; Ralph W. Gilmore and wife, Elizabeth R. Gilmore; Maria B. Campbell, a single woman; Margaret Campbell Gunn and husband, Julian Gunn; Valerie R. Cooper, a single woman, and Allen E. Shealy, a single man

(herein referred to as grantors) do grant, bargain, sell and convey unto

CLYDE E. BUZZARD and wife LINDA F. BUZZARD

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in SHELBY COUNTY, ALABAMA to-wit:
