said GRANTOR does by these presents, grant, bargain, sell and convey unto

(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor  
of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate,  
situated in Shelby County, Alabama, to-wit:

Part of the SW 1/4 of SE 1/4 of Section 16, Township 19 South, Range 2 West, Shelby  
County, Alabama, being more particularly described as follows: From the Southeast  
corner of said 1/4-1/4 section, run in a westerly direction along south line of said  
1/4-1/4 section for a distance of 621.00 feet, thence turn an angle to the right of  
115 degrees 14 minutes and run in a northeasterly direction for a distance of 753.30  
feet to a point of beginning, thence continue along last mentioned course for a  
distance of 216 feet to a point on the southwest line of a 35 foot easement for a  
road, thence turn an angle to the right of 122 degrees 48 minutes and run in a  
southeasterly direction along the southwest line of said 35 foot easement for a  
distance of 165 feet, thence turn an angle to the right of 79 degrees 30 minutes and
