(herein referred to as GRANTEES) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama to-wit:

A parcel of land contained in the W $\frac{1}{2}$ of the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ and the E $\frac{1}{2}$ of the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 9, Township 22 South, Range 3 West, more particularly described as follows:

Starting at the SW corner of the NE $\frac{1}{4}$ of said section run North 0° 15' West for 1819.25 feet along the west boundary of the NE $\frac{1}{4}$ of said section to an iron pipe on the south boundary of Keeler Hill Road, the point of beginning; thence run in a southeasterly direction along the south boundary of said road for 795.0 feet to an iron pipe; thence run South 0° 07' West for 597.0 feet along the east boundary of the W $\frac{1}{2}$ of the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ of said section to an iron pipe; thence run North 58° 56' West for 868.54 feet to an iron pipe on the east right of way of Shelby County Highway No. 15; thence run North 6° 14' East for 163.20 feet along the east right of way of Highway No. 15 to an iron pipe; thence continue along the east right of way of Highway No. 15, North 6° 09' East for 395.59 feet to an iron on the south boundary of Keeler Hill Road; thence run South 75° 52' East for 17.36 feet back to the point of beginning.
