the receipt of which is hereby acknowledged, the said Lee Land & Development Co., Inc.

does by these presents, grant, bargain, sell and convey unto the said L & M Homes, Inc.

the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot #8, Block #1, in the Third Sector of Fall Acres Subdivision. Situated in and being a part of the SE 1/4 of the NE 1/4 of Section 3, Township 21 S., Range 3 West, Shelby County, Alabama. This is recorded in Map Book 5, page 79, in the Probate Office in Shelby County, Alabama.

Subject to restrictions as follows:

" All lots are for residential purposes only, and dwellings shall have a minimum of 1,600 square feet in the main body of the house. No structures of a temporary nature, such as trailers, tents, shacks, basements, garages, or other outbuildings shall be used as a residence either temporarily or permanently," and this covenant shall attach to and run with the land.

Also subject to current and subsequent years taxes, set back lines, restrictive covenants of record, rights of ways of record, transmission line permits of record.
