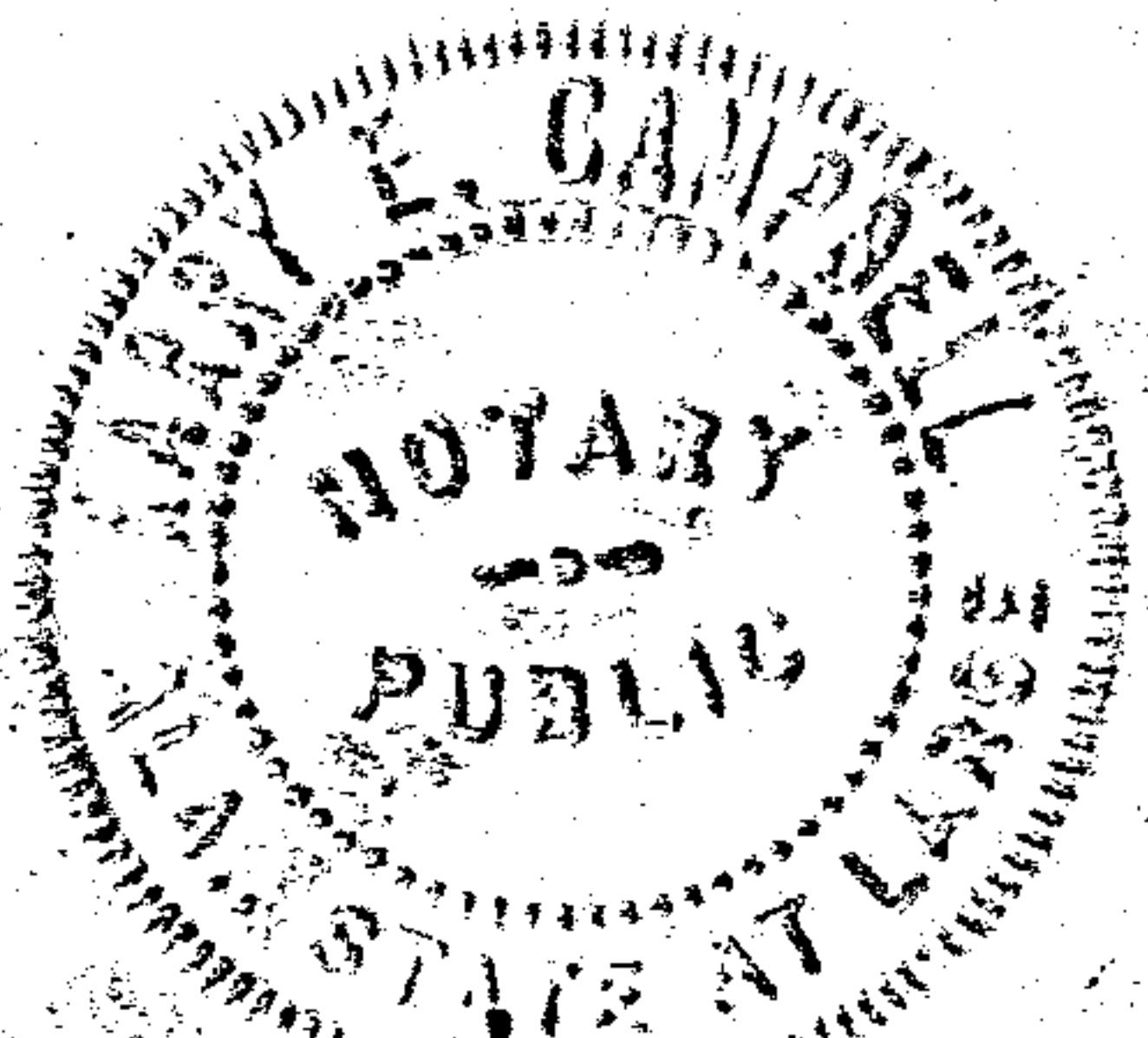
EASEMENT

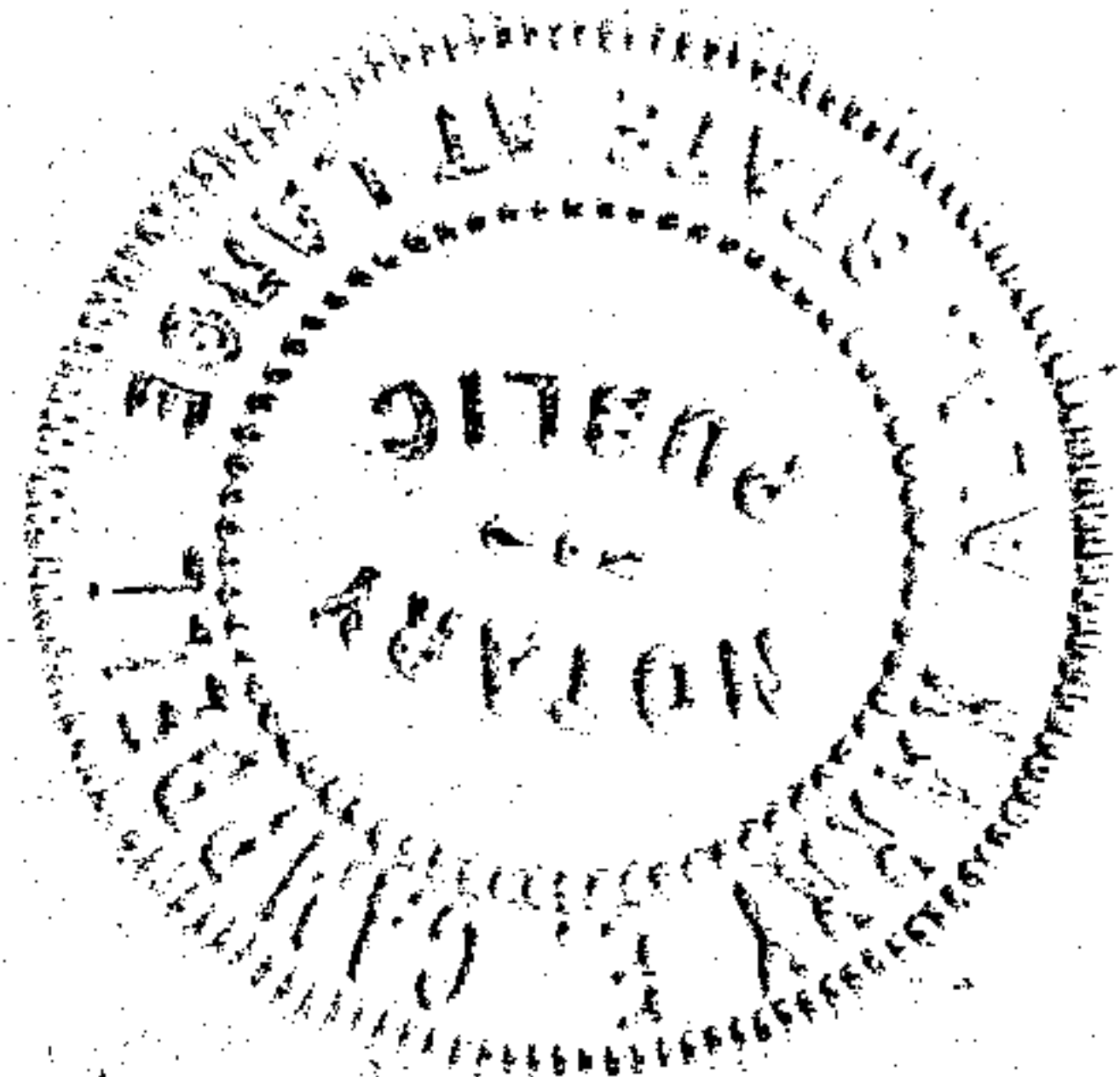
