WHEREAS, a portion of the indebtedness secured by said
mortgage has now been paid in full to said Mortgagee,

NOWTHEREFORE, said Mortgagee (Assignee), for and in consideration of these premises, and for and in consideration of the further sum of One and No/100 (\$1.00) Dollars to him in hand paid, the receipt whereof is hereby acknowledged, does hereby release and discharge from the terms and conditions of said mortgage designated above, and from the encumbrances of said mortgage, the following described land, located in Shelby County, Alabama, to-wit:

Commence at the Southeast corner of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$, Section 24, Township 19 South, Range 1 East; thence run West along the South line of said quarter-quarter section a distance of 316.78 feet to the point of beginning; thence continue in the same direction along said South line a distance of 335.83 feet to the Southwest corner of the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of said Section 24; thence turn an angle of 91 deg. 27 min. 51 sec. to the right and run a distance of 1227.50 feet to the South right of way line of U. S. Highway No. 280; thence turn an angle of 121 deg. 34 min. 15 sec. to the right and run along said highway right of way a distance of 193.93 feet; thence turn an angle of 4 deg. 04 min. 50 sec. to the right and continue along said right of way a distance of 150.61 feet; thence turn an angle of 00 deg. 56 min. 05 sec. to the right and continue along said right of way a distance of 61.19 feet; thence turn an angle of 53 deg. 31 min. 06 sec. to the right and run a distance of 992.54 feet to the point of beginning. Situated in the E $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the SE $\frac{1}{4}$, Section 24, Township 19 South, Range 1 East, Huntsville Meridian, Shelby County, Alabama, according to survey of Frank W. Wheeler, Registered Land Surveyor, dated February 16, 1976.

The said mortgagees acknowledge payment on this date by the mortgagors of the sum of \$1,000.00, to be applied against the principal indebtedness owing on said mortgage and that the balance owing on said mortgage, after payment of said sum of \$1,000.00, is the sum of \$11,500.00.
