The Mead Corporation, an Ohio Corporation with offices at 118 West
First Street, Dayton, Ohio, 45402, --as Lessor,
and Southern Stone Company, Inc. as Lessee

for and in consideration of the sum of ONE AND 00/100 Dollars (\$ 1.00)
to _____ in hand paid by Alabama Power Company, a corporation, the receipt whereof is ac-
knowledgeed, do hereby grant to said Alabama Power Company, its successors and assigns, the right to
construct, operate and maintain electric transmission and communication lines and all towers, poles,
conduits, conductors, cables, insulators, anchors, guy wires, counterpoise conductors, and all other ap-
pliances necessary or convenient in connection therewith from time to time over, under and across, a
strip of land varying _____ feet in width, as said strip is now located by the
final location survey thereof heretofore made by said Company, over, under and across the lands of which
it is hereinafter described as being a part, said survey to determine the boundaries of said strip, together
with all the rights and privileges necessary or convenient for the full enjoyment or use thereof for the
purposes above described, including the right of ingress and egress to and from said strip and the right
to cut, remove, or otherwise kill, and keep clear by any means, including chemicals, all trees and under-
growth and all other obstructions under, on or above said strip and danger trees adjacent thereto which
now or may hereafter injure, endanger or interfere with any of the works on said strip, and the right to
install, maintain and use anchors and guy wires on land adjacent to said strip, and the right to pre-
vent the use of such strip as a parking area for automobiles or other vehicles, as a storage area for
machinery or materials, or as a road other than a road crossing such strip at a location which does not
endanger or interfere with works that have been or may at some future date be constructed on
such strip.

Said strip is a part of a tract of land situated in Shelby
County, Alabama, described as follows: Southeast quarter of the southwest quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) of
Section 7, Township 21 south, Range 2 west. Said strip is approximately described as follows:
Commence at the northwest corner of the southeast quarter of the southeast quarter of Section 7,
Township 21 south, Range 2 west; thence run south along the west boundary line of said quarter-
quarter Section a distance of 521.97 feet to a point; thence turn an angle to the left of 45 degree
0 minutes and run south 45 degrees 01 minutes east a
distance of 133.2 feet to a point; thence turn an angle to the left of 14 degrees 25 minutes and
run south 59 degrees 26 minutes east a distance of 115 feet, more or less, to a point on the north
boundary line of the Grantor's property, such point being the point of beginning of the right of wa-
herein described; therefrom, the strip lies 25 feet right of and to Highway 31 left of a survey line
and the continuations thereof which begins at such point of beginning and runs south 59 degrees 26
minutes east a distance of 681.6 feet to a point; therefrom, the strip lies 25 feet on each side of
center line and the continuations thereof which begins at such point and turns an angle to the
left of 61 degrees 46 minutes and runs north 58 degrees 48 minutes east a distance of 369 feet to a
point; thence such center line turns an angle to the left of 29 degrees 57 minutes and runs north
8 degrees 51 minutes east a distance of 111.6 feet to a point; thence such center line turns an
angle to the left of 65 degrees 28 minutes and runs north 36 degrees 37 minutes west a distance of
0 feet, more or less, to a point on the north boundary line of the Grantor's property, such point
being the point of ending of the right of way herein described.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns, forever.

The grantors shall have the right to cultivate and use said strip of land for any purpose not incon-
sistent with the rights which the grantee may from time to time exercise hereunder.
