1. Petitioner is over 21 years of age and resides at Montevalle Alabama.
2. Petitioner owns all of the land hereinafter described in this petition.
3. Petitioner hereby makes application to the Shelby County Commission for approval of the location or extension of a family cemetery as provided by Title 22, Section 88 of the Code of Alabama of 1940. The proposed cemetery plot is an area 40 feet by 40 feet square and is located as follows:

Begin at the SW corner of the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 36, Township 21 South, Range 3 West and go thence north along the west line of the SE $\frac{1}{4}$ of the said SW $\frac{1}{4}$ a distance of 1,172 feet to the SW corner of said proposed cemetery plot; thence easterly and perpendicular to said west line 40 feet; thence northerly parallel to said west line 40 feet; thence westerly and perpendicular to said west line 40 feet; thence along the west line of said SE $\frac{1}{4}$ of said SW $\frac{1}{4}$ 40 feet to the point of beginning.

Said property is not located within the municipal limits of any municipality in Shelby County.
4. Petitioner prays that the County Commission will have the County Board of Health or its lawful representative make an investigation of the proposed cemetery location or extension thereof and give approval thereto.
5. Petitioner further prays that upon approval of this petition by the Shelby County Health Department, that the Shelby County Commission shall cause the license to be issued to establish or extend said cemetery plot as hereinabove described.
