DESCRIPTION:

Lot 3-A and part of Lot 3 according to the map and survey of Mountain View Lake Company, First Sector, as recorded in Map Book 3, Page 135 in the Probate Office of Shelby County, Alabama and being more particularly describe as follows: Commence at the most southerly corner of said Lot 3; thence run northwesterly along the westerly line of said Lot 3 for 82.0 feet; thence 91° 10' right and run northeasterly for 243.0 feet to a point on the waters edge of the lake, said point being the point of beginning of the property herein described; thence reverse the last stated course and run southwesterly for 243.0 feet; thence 88° 50' right and run northwesterly along the westerly line of said Lot 3 for 155.20 feet to the corner between Lot 3 and Lot 3-A; thence 51° 45' right and run northeasterly for 212.85 feet to the corner between Lot 3-A and Lot 4; thence 114° 09' right and run southeasterly along the northerly line of said Lot 3-A, and said line extended for a distance of 113 feet, more or less, to a point on the waters edge on said lake; thence run southerly and southeasterly, running along the waters edge of said lake, for a distance of 208 feet, more or less, to the point of beginning.
