Then turn an angle of 93 deg 33 min 00 sec to the right and run 74.0 ft., then turn an angle of 89 deg 17 min 00 sec to the left and run 36.1 ft.; then turn an angle of 94 deg 16 min 13 sec to the left and run 76.55 ft., then turn an angle of 90 deg 00 min 00 sec to the left and run 31.42 ft. back to the point of beginning.
