Before me, the undersigned authority,
appeared Nobie Jean C. Davidson, known to me, who,
did, upon her oath, depose and say as follows:

My name is Nobie Jean C. Davidson. I am
the widow of Robert B. Davidson, Jr., who is the
named grantee in that certain deed from W. J. Strickland
to Robert B. Davidson, Jr., dated July 31, 1959 and
recorded in the office of the Judge of Probate of
Shelby County in Deedbook 205, page 343. I have on
this date executed a warranty deed to The Helena
Baptist Church for a portion of the said property
described in the above referred to recorded deed,
title having become vested in affiant grantor by
virtue of the Last Will and Testament of my late
husband, Robert B. Davidson, Jr., which Will
was probated in the Shelby County Probate Office. The
said property conveyed by me to The Helena Baptist Church
on this date is a part and parcel of that certain property
conveyed to Robert B. Davidson, Jr., recorded in Deed-
book 205, page 343, in the Probate Records of Shelby County,
Alabama, and my said conveyance to said Church does not
contain any other property.

Robert B. Davidson, Jr., during his lifetime,
held the said property described under title in the above
referred to recorded deed derived from the said W. J.
Strickland. The said Robert B. Davidson, Jr., built a
house on the said property and he and I lived in it
several years before his death. I have at all times
continued to live thereon since his death and reside

there at the present time. Robert B. Davidson, Jr., and I have claimed the said property as our own for more than the last past fifteen years, our possession has been hostile and under claim of right, actual, open and notorious, exclusive and continuous. No one else during the said period of time from the date of the deed of W. J. Strickland to Robert B. Davidson, Jr., in 1959, (said recorded deed referred to above) has claimed any ownership, title or interest in or to said property, nor been in the possession of the same. My husband and I have had the said property assessed and paid taxes thereon each year for more than the last fifteen years.
