KNOW ALL MEN BY THESE PRESENTS:

That in consideration of Three Thousand and No/100 (\$3,000.00) Dollars

to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we, Robert Goggins and wife, Geraldine Goggins; Eva G. Allen, and husband, Walter Murray Allen; Frances G. Liddle, a widow; Katherine G. Grill, a widow; Eugene Goggins and wife, Billie Goggins; Marshall Goggins and wife, Dorothy Goggins; and Leonard Goggins and wife, Marlene Goggins, (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto

Mary Goggins

(herein referred to as grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

A part of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 3, Township 22 South, Range 4 West, described as follows: Commencing at the NW corner of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ and run North 86 deg. 28 min. East along North line of said forty a distance of 440 feet to point of beginning; thence run South 3 deg. 47 min. East and parallel to the West side of said forty, 701 feet to a stake on the North side of the Aldrich and Boothton Public Road; thence South 78 deg. 37 min. East along the North side of said road 186 feet; thence North 3 deg. 47 min. West and parallel to West line of said forty 749 feet to North line of said forty; thence South 86 deg. 28 min. West 179.5 feet along North line of said forty to point of beginning, EXCEPTING tract sold to Ira Goggins as described in Deed Book 110, page 261. Excepting highway right of way. MINERALS AND MINING RIGHTS EXCEPTED, and subject to easements and rights of way of record.

The grantors warrant that the above described property was owned by J. L. Goggins at the time of his death; that said J. L. 
