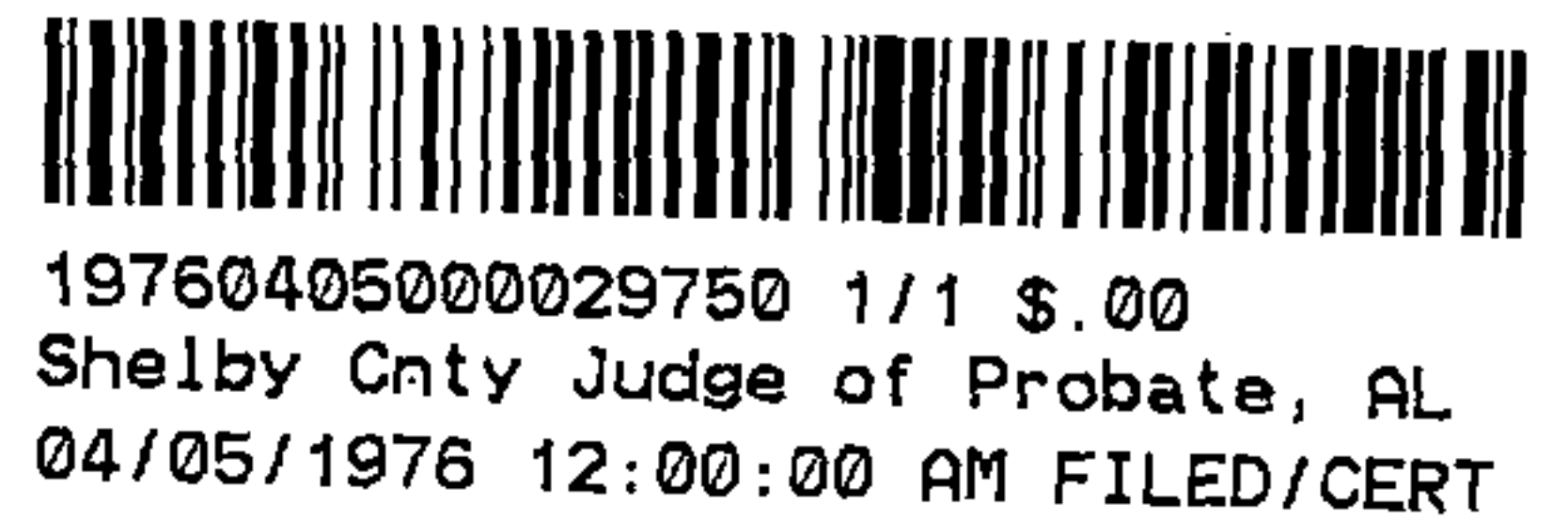


SATISFACTION OF NOTE AND SECURITY
