HASKINS W. BOWMAN AND WIFE, MARY S. BOWMAN

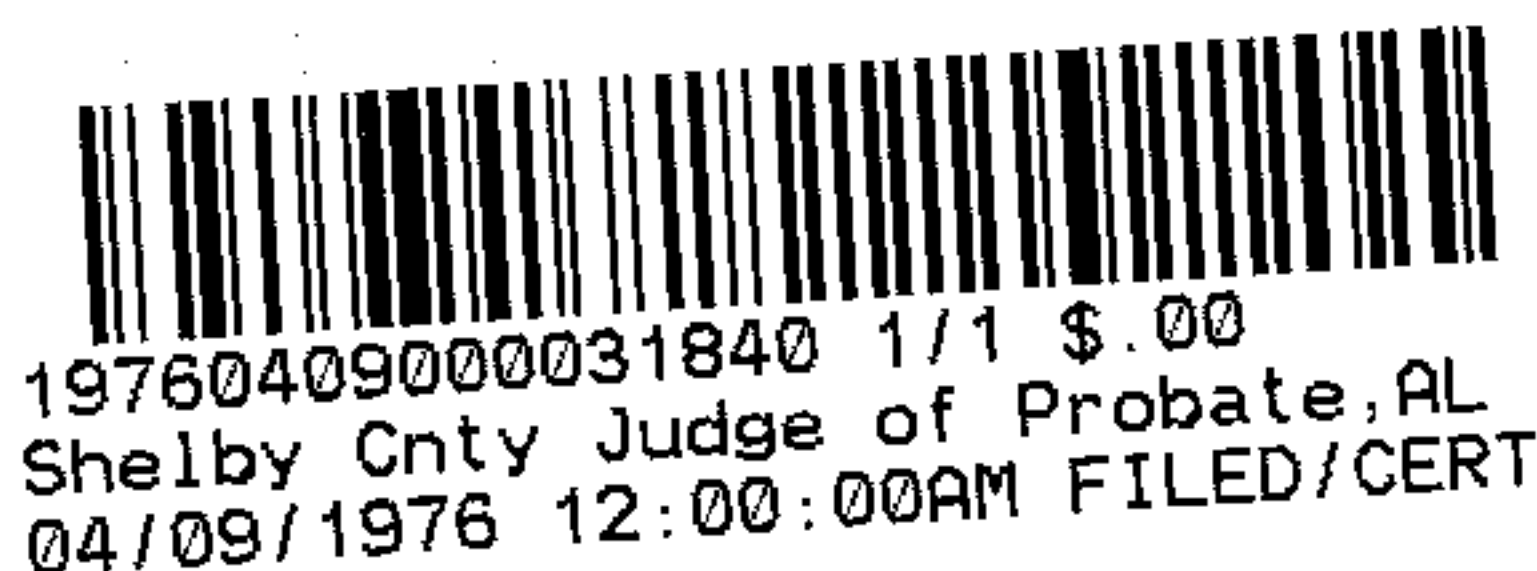
