WHEREAS, the undersigned parties wish to make a complete, total and extra-judicial settlement of the aforesaid claim,

KNOW ALL MEN BY THESE PRESENTS that the undersigned have reached the following agreement for a total, complete satisfaction of the aforesaid debt and claim against the said estate. For the sole consideration of One Thousand Three Hundred Thirty-three and 33/100 dollars (\$1,333.33), the receipt and sufficiency whereof is hereby acknowledged, the said Phillip Ralph Wells hereby releases and forever discharges Ted Wayne Wells and Betty Wells, their heirs, executors, administrators, agents and assigns and all other persons, firms or corporations from any and all claims, demands, damages, actions, causes of actions, or suits of any kind or nature whatsoever which may result from the aforesaid claim of the estate of Cecil R. Wells and Myrtle Wells.

FURTHERMORE, for the sole consideration of One Thousand Three Hundred thirty-three and 33/100 dollars (\$1,333.33), the receipt and sufficiency whereof is hereby acknowledged, the said John Richard Wells hereby releases and forever discharges the said Ted Wayne Wells and Betty Wells, their heirs, executors, administrators, agents and assigns, and all persons, firms, corporations from any and all claims, demands, damages, actions, causes of actions, or suits of any kind or nature whatsoever which may result from the aforesaid claim of the estate of Cecil R. Wells and Myrtle Wells.

We do hereby agree that the aforesaid payments which the receipt of is hereby acknowledged shall act as a total, complete discharge of the said Ted Wayne Wells and Betty Wells from any and all claims, actions, causes of actions, or suits of any kind whatsoever relating to a promissory note executed by Ted Wayne Wells and Betty Wells on the 11th day of October, 1967, which was the basis for the claim by the estate of the said Cecil R. Wells and Myrtle Wells which is the basis of this release.
