Packer, a widow; Jane H. Aaron and husband, John B. Aaron; Mary H. Chiles and husband, A. E. Chiles; Alice Jeanne Huddleston, a widow, sole legatee of George Huddleston, Jr.; George Huddleston, III, an unmarried man; Margaret Huddleston, an unmarried woman; Nancy Huddleston, a minor, by her Guardian, John Huddleston; and John Huddleston and wife, Judith B. Huddleston (herein referred to as GRANTORS), do hereby GRANT, BARGAIN, SELL and CONVEY unto Huddleston Land & Timber Company (herein referred to as GRANTEE), its successors and assigns, the following described Real Estate, situated in the County of Shelby, State of Alabama, to wit:

A part of the SE $\frac{1}{4}$  of NW $\frac{1}{4}$  of Section 17, Township 19 South, Range 1 West, described as follows: Begin at the SW corner of said  $\frac{1}{4} \frac{1}{4}$  Section and run East along South line a distance of 99 feet; thence Northwesterly to a point which is 121 feet North of South line of said  $\frac{1}{4} \frac{1}{4}$  Section and 74 feet East of the West line of said  $\frac{1}{4} \frac{1}{4}$  Section; thence West 74 feet to the West line of said  $\frac{1}{4} \frac{1}{4}$  Section; thence South to point of beginning.




