
JARRANTY DEED



KNOW ALL MEN BY THESE PRESENTS, that in consideration of One Hundred Dollars and other valuable considerations to the undersigned GRANTORS in hand paid by the GRANTEE herein, the receipt whereof is hereby acknowledged, we, Nancy H. Chiles; Alice Jeanne Huddleston, a widow, sole legatee of George Huddleston, Jr.; George Huddleston, III, an unmarried man; Margaret Huddleston, an unmarried woman; Nancy Huddleston, a minor, by her Guardian, John Huddleston; and John Huddleston and wife, Judith B. Huddleston (herein referred to as GRANTORS), do hereby GRANT, BARGAIN, SELL and CONVEY unto Huddleston Land & Timber Company (herein referred to as GRANTEE), its successors and assigns, the following described Real Estate, situated in the County of Shelby, State of Alabama, to wit:

A part of the SE½ of NW½ of Section 17, Township 19 South, Range 1 West, described as follows: Begin at the SW corner of said ½ ½ Section and run East along South line a distance of 99 feet; thence Northwesterly to a point which is 121 feet North of South line of said ½ ½ Section and 74 feet East of the West line of said ½ ½ Section; thence West 74 feet to the West line of said ½ ½ Section; thence South to point of beginning.
