That, Southern Natural Gas Company, a corporation under the laws of the State of Delaware, and having its principal business offices in Birmingham, Alabama (hereinafter called "Vendor"), for and in consideration of the sum of Two Thousand and No/100 Dollars (\$2,000.00) to it in hand paid, at or before delivery of these presents, by Portsouth Subdivision, a corporation under the laws of the State of Alabama (hereinafter called "Vendee"), the receipt and sufficiency whereof is hereby acknowledged, has bargained and sold, and does hereby bargain, sell, convey and deliver unto the said Vendee any and all rights and interests in the following described property to-wit:

That certain tract of land located in the NW 1/4 of SW 1/4 of Section 26, Township 20 South, Range 3 West, Shelby County, Alabama, known as Portsouth Subdivision, together with associated piping. *NEW*

That Vendor does, by these presents remise, release, sell and convey and quitclaim, without any warranty whatsoever, not even for the return of the purchase price, the described property. It is further understood and agreed by Vendee that any and all pipe which is conveyed by this Bill of Sale and Agreement is sold as where is, without warranty as to the condition or fitness of said pipe for any purpose whatsoever; and further, from and after the date hereof, Vendor shall have no liability with respect to said pipe and Vendee shall indemnify and hold harmless from any loss, cost or expense in connection with any claim arising out of the ownership or use of the pipe conveyed hereby.

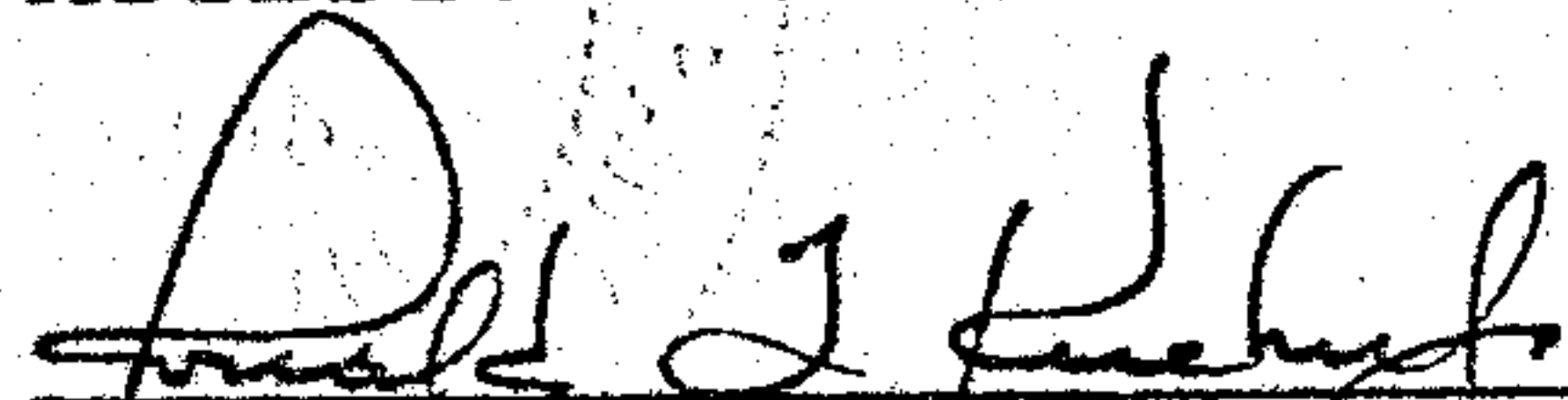

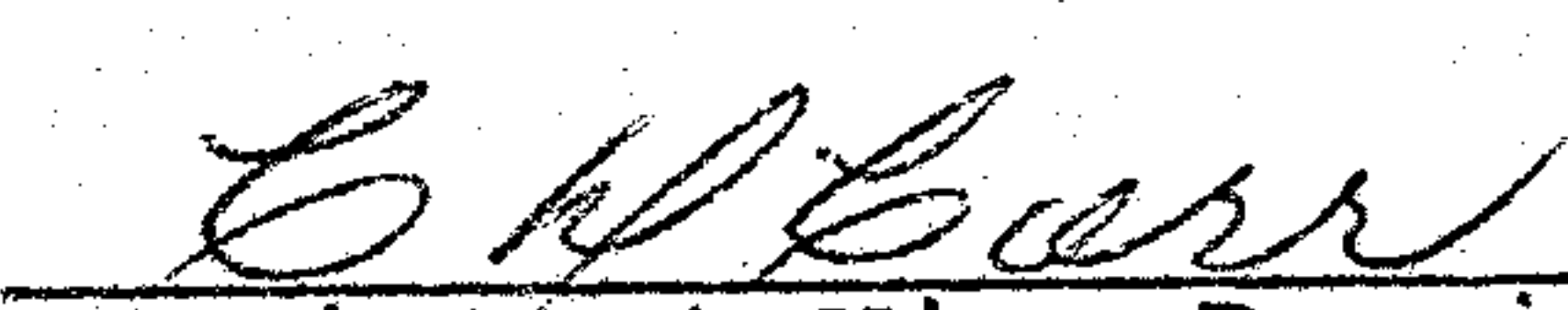

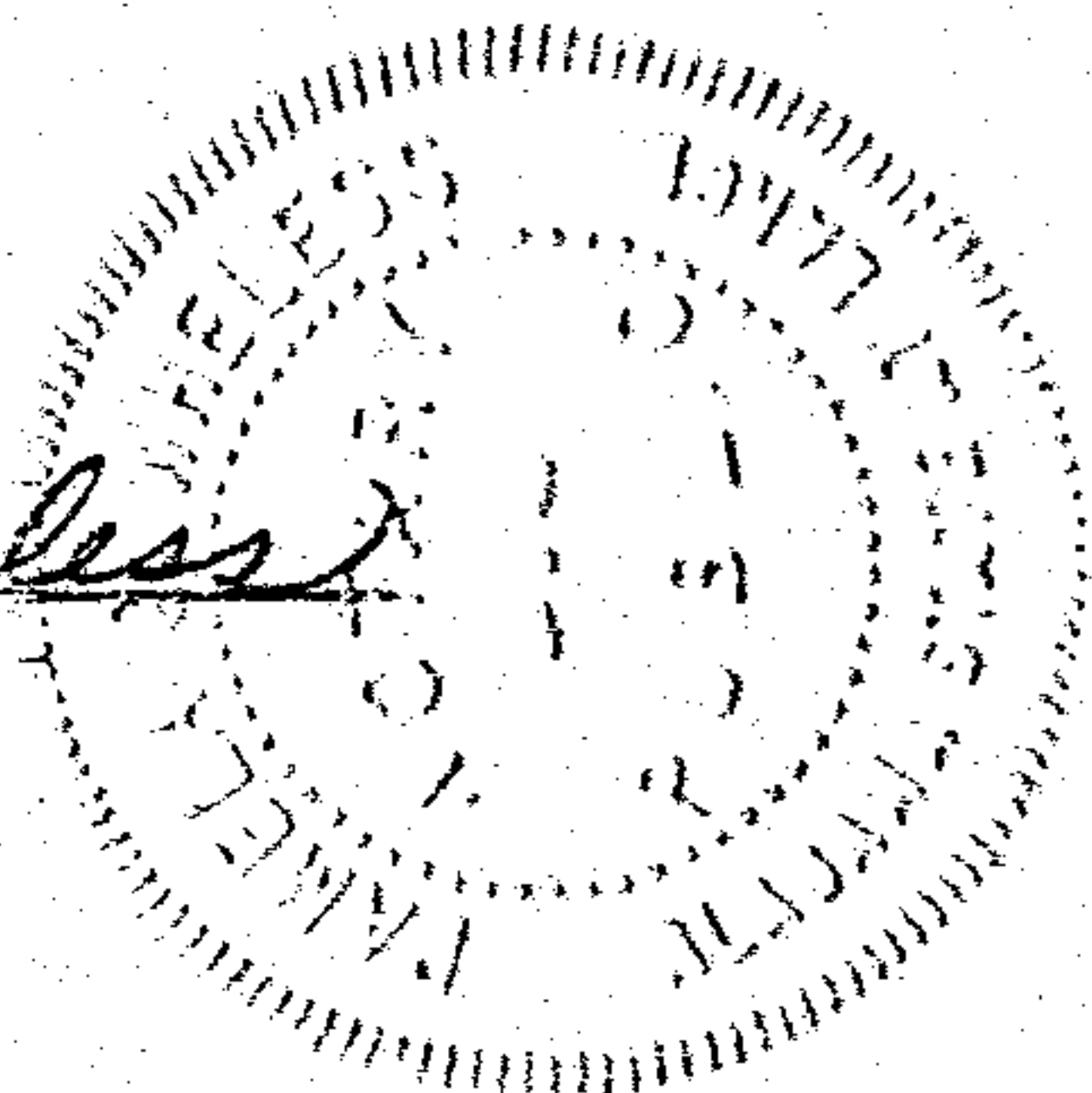
