Said easement is to be used as a means of ingress and egress to and from that portion of the NE $\frac{1}{4}$  of Section 23, Township 19 South, Range 2 East, Shelby County, Alabama, lying East of the Central of Georgia Railroad right-of-way.

It is agreed between the parties hereto that this easement is personal to the party of the first part or their agents and shall not inure to the successors or heirs of the party of the first part.

The parties hereto agree further that party of the first part shall so maintain and operate the right-of-way herein granted that the operation thereof would in no way hinder or prevent the proper and reasonable use, by the party of the second part, of the property through which the easement is hereby granted.

Party of the first part agree to observe maximum safety precautions in exercising their rights under said easement and agree to hold party of the second part harmless in the event party of the first part or their agents should be negligently injured or damaged in the exercise of this easement.
