§ ITEM ONE §

I give, will, devise and bequeath all of my property, real, personal and/or mixed, wherever situated, which I may own or to which I may be entitled at the time of my death, or to which my estate may become entitled after my death, or over which I may have any power of disposition, unto my beloved niece, REBECCA CLEMONS, to be hers absolutely.

If, however, my beloved niece precedes me in death, then it is my will, and I do hereby give, will, devise and bequeath all of my said property to the descendants of my said niece, REBECCA CLEMONS, share and share alike, per stirpes.
